DNR Hires New Storm Water Program Coordinator

The Iowa Department of Natural Resources has a new storm water program coordinator.

David Schelling will start as the new storm water coordinator for the National Pollutant Discharge Elimination System (NPDES) section on Nov. 11.

Based in Polk City, Schelling has spent the past 17 years working for the state of Iowa - half with the department as an industrial NPDES permit writer and half with the State Hygienic Laboratory in the Limnology department. He holds a Bachelor of Science degree in animal ecology from Iowa State University.

With the hire, the department is looking to put an increased emphasis on outreach to communities and stakeholders. As storm water coordinator, Schelling hopes to increase engagement with Municipal Separate Storm Sewer System (MS4) communities and improve individual permits to make them easier to understand and implement. Staff will also be working to improve the user experience of the online storm water permitting application.

"I want the role to evolve to a partner to the people utilizing the permits," he said.

EPA Releases BABA Implementation Guidance to States

On Nov. 7, 2022, the Environmental Protection Agency (EPA) released long-awaited guidance to State Revolving Fund (SRF) Programs on how to implement the Buy America, Build America (BABA) Act for recipients of SRF and Bipartisan Infrastructure Law (BIL) Funding. BABA was a provision within the Infrastructure Investment and Jobs Act (IIJA), which was signed into law on Nov. 15, 2021 and is now referred to as BIL. BABA mandates that all federal funding for public infrastructure projects use domestically sourced iron, steel, manufactured goods and construction materials.

BABA was effective on May 14, 2022. Since then, EPA has released an Adjustment Period Waiver (9-2-2022), a Small Project General Applicability Waiver (9-28-2022), and a De Minimis General Applicability Waiver (10-24-2022). The release of the BABA Implementation Guidance

this week is the first written guidance the state SRF programs have been offered in developing processes and procedures for achieving compliance with this new federal funding provision.

The EPA will be offering a webinar to states and regional EPA offices next week. EPA training for SRF borrowers is anticipated to begin before the end of the calendar year. Additional guidance and training will be offered to SRF borrowers, consultants, and contractors in calendar year 2023.

First Round FFY 2022 BIL Loan Forgiveness Awards Announced

The first State Revolving Fund (SRF) loan forgiveness awards have been determined for the federal fiscal year (FFY) 2022 Clean Water and Drinking Water SRF base programs and for the FFY 2022 Bipartisan Infrastructure Law (BIL) General Supplemental Funds for both Clean Water and Drinking Water. This first round of awards selected projects from the current approved Intended Use Plan (IUP) Project Priority List, which includes projects approved by the Environmental Protection Commission up to the second quarter of State fiscal year 2023.

The eligible projects selected in this first round consist of projects that have closed an SRF loan this fiscal year, meet the Iowa SRF disadvantaged community affordability criteria (socioeconomic assessment score), AND are constructing a priority project.

The IUPs cover the CWSRF and DWSRF base programs for SFY 2023 (July 1, 2022 to June 30, 2023), and the Annexes cover the Federal fiscal year (FFY) 2022 Bipartisan Infrastructure Law (BIL) General Supplemental Funds.
