Apply now for the Career Academy Incentive Fund



The Career Academy Incentive Fund is now accepting proposals for the first round of funding for fiscal year 2023. Grant submissions will be accepted through Nov. 3.

CAREER ACADEMY INCENTIVE FUND Partnerships between Iowa school

districts and local community colleges that promote equitable access to highquality <u>career and technical education (CTE)</u> programs are strongly encouraged to apply. Priority consideration will be given to applicants who focus on programming delivered through a regional center, a central location that offers high school students from several school districts the opportunity to explore career options while earning both high school and college credit.

The <u>Career Academy Incentive Fund</u> is provided through the 2019 reauthorization of Secure an Advanced Vision for Education (SAVE), and individual grant programs can be awarded up to \$1 million for career academy development and expansion. The number of grant awards is based on the amount of funds available and the scope of projects submitted.

Last year, six grants were awarded to partnerships across the state totaling \$5.5 million. Recent recipients include Indian Hills Community College, Western Iowa Tech Community College, Des Moines Area Community College, Iowa Lakes Community College, Iowa Western Community College and North Iowa Area Community College.

Career academies play an important role in expanding access to CTE programs for lowa's students. Valuable skill development, career exploration, work-based learning and professional training for high-demand careers are provided through career academies.

lowa Student Outcomes website features one-stop shop for education outcomes data



Planning for the future of education in Iowa calls for data that is not only reliable but also easily accessible. Enter Iowa Student Outcomes, a comprehensive, interactive website that houses education-related data and serves as a useful resource for any decision-maker.

Through a partnership between the Iowa Department of Education, Iowa Workforce

<u>Development</u>, <u>Iowa College Aid</u>, <u>Future Ready Iowa</u> and <u>Iowa Board of Regents</u>, the <u>Iowa Student Outcomes</u> website offers users access to a variety of reports and interactive dashboards detailing information on trends in K-12, community colleges, adult education, Iowa public universities, registered apprenticeships and employment. College leaders, school administrators, government officials and students exploring different career and education pathways are encouraged to use the site.

"Successful student outcomes require research and review, which can take time to collect," said Paula Nissen, administrative consultant at the Iowa Department of Education. "Iowa Student Outcomes provides a one-stop resource on student populations in Iowa."

Visitors to the site have easy access to several categories of data, and compelling statistics on the homepage welcome users to peruse the site further. Examples of current data highlighted on the site include:

- Sixty-three percent of Iowa public high school graduates enrolled in postsecondary education within one year.
- More than 7,860 lowa students received the Last Dollar Scholarship in 2021 for in-demand careers.
- Ninety-two percent of community college students who completed a credit program became employed in their first year post-graduation.
- Over 71,700 students enrolled in Iowa public universities.
- Nearly 1,400 adult learners earned a high school equivalency diploma in 2020.
- There are over 30,600 active Certified Nurse Assistant certificates in Iowa.
- Close to 8,000 active apprentices in Iowa were noted during the first quarter of 2021.

Department awards paraeducator certification grants



The lowa Department of Education has awarded over 1.18 million dollars in competitive grants to 10 institutions offering paraeducator certification. The purpose of the grant is to support paraeducators participating in the TPRA grant along with paraeducators pursuing additional training and certification; the grant funds cover the cost of tuition, fees and books. The grant has the potential of training 800 paraeducators in the state of Iowa.

The ten institutions awarded a Title II Paraeducator Grant for summer and fall of 2022 include:

Park and Institutional Roads Program Fund application process now open

The <u>State Park and Institutional Roads Program</u> application process is now open. Submissions close Friday, October 28, 2022, at 11:59 PM.

The fund provides funding to construct, reconstruct, improve and maintain roadways, including bridges, within the boundaries of state-owned lands or community college property. Sixty-five one-hundredths of one percent of the Road Use Tax Fund is allocated for maintenance and improvement of the State Park and Institutional Roads system. There are over 600 miles of roadways in the Park and Institutional Roads System. State agencies participating in the program are the Iowa Department of Corrections (DOC), the Iowa Department of Education (DOE), State Fair Board, Department of Human Services (DHS), National Guard of Iowa,

Department of Natural Resources (DNR), Board of Regents and Department of Administrative Services (DAS) Capitol Complex. Each agency is allocated a percentage of the fund based on the Iowa Code, as follows: Iowa DNR (45.5%), Board of Regents (30%), Iowa DHS (6.5%), Iowa DOE (6%), Iowa DOC (5.5%), National Guard of Iowa (4%), State Fair Board (2%) and Iowa DAS Capitol Complex (0.5%). Register now for Iowa BEST Summit



Registration is under way for the 2022 Iowa BEST (Behavioral, Equitable, Social-Emotional, Trauma-Informed Health in Schools) Summit to be held in Des Moines Oct. 10-11. The summit is designed for PreK-12 educators, counselors, administrators, paraeducators and school mental health providers. In addition, AEA personnel who support social, emotional and behavioral health, university faculty who support preservice educators and community stakeholders are encouraged to attend.

Sponsored by the Iowa Department of Education and the Iowa Center for School Mental Health, the summit will focus on practical solutions for school-based social, emotional and behavioral health.

Participants will learn how to take a holistic approach within their schools, incorporating the latest research, resources and best practices. The goal is to build mental wellness supports and capacity for schools, districts and regions.

Keynote speakers are Robert Brooks and Erika McDowell.

Brooks has lectured nationally and internationally to audiences of parents, educators, mental health professionals, and business people on topics pertaining to motivation, resilience, family relationships, the qualities of effective leaders and executives, and balancing our personal and professional lives. Brooks has written extensively on behavioral issues in the classroom setting.

McDowell is an Equity Steward for Wildflower Schools and a clinical associate professor of educational leadership and policy at the State University of New York (SUNY) at Buffalo. Her in-depth experience includes restorative practices, equity, positive behavioral support, conflict resolution, classroom management, coaching, leadership development, and behavioral data support. Dr. McDowell is committed to nurturing the minds and gifts of leaders, teachers, practitioners, and youth nationwide.
