The bill, providing federal per diem payments to be set aside in a special fund for matching money for renovation, remodeling or construction of new facilities, is now in committee in the House and Senate of Iowa Legislature.

This legislation House File 1114 was introduced by Representative Harold Fischer of Grundy County and co-sponsored by Representatives Larry L. Perkins of Pottawattamie County Sub-District #3. Keith Dunton of Keokuk County, John Tapscott of Polk County Sub-District #11 and Donald L. Lippold, Black Hawk County District #5. The companion bill, Senate File 1109, was introduced in the Senate by Senator John L. Mowry of Marshall County and co-sponsored by Senators William F. Denman of Polk County District #3, Elmer F. Lange of Calhoun, Ida and Sac Counties and James E. Briles of Adams, Montgomery, Taylor and Union Counties.

The Veterans' Organizations of Iowa believe that this legislation is necessary and the easiest way for Iowa to secure the matching funds which are available at the Veterans Administration in Washington, D. C. Veterans Administration Administrator Donald E. Johnson, at the Commanders and Adjutants Conference in February, reminded the convention and the Solons present that this is an opportunity for Iowa to get ready for the large veteran population of 65 years and over who will be knocking at the door of the Iowa Soldiers' Home for service for some 178,000 members by 1982.

### REMOTIVATION SESSIONS

Remotivation sessions are structured discussion groups of ten to twelve residents led by nursing personnel. The purpose of these groups are to provide stimulus for thinking, to assist in maintenance of orientation, and to promote socialization among residents. There has been an on-going Remotivation Program at the Iowa Soldiers' Home for two years which has proven successful in terms of benefits, to both residents and staff. In keeping with our objective of being a demonstrative facility, Darlene Longman, Remotivation Coordinator, has recently met with persons interested in Remotivation from other communities and care settings.

On March 3 Mrs. Longman and Nancy Finders, an Iowa Soldiers' Home Remotivator, demonstrated Remotivation techniques to a volunteer group in a nursing home in Cedar Rapids. The demonstration was followed by discussions with the group and plans to teach the formal 30 hour Remotivation Course to the group.

On March 19 Mrs. Longman and Janet Specht, Director of Nursing, met with twelve nursing directors from the Des Moines area nursing homes at Riverview Manor in Des Moines. The discussion centered on the methods and objectives of Remotivation. Plans are being made for Mrs. Longman to teach the Remotivation Course to representatives from these twelve homes. Thus, the numbers of aging and chronically ill persons benefiting from this proven technique will rapidly expand.

Remotivation adds another dimension to patient care equally important to physical care -that of stimulation and socialization. The Iowa Soldiers' Home is providing leadership for the use of Remotivation in Iowa Nursing Homes.
