BEDS CLOSED!

Jack J. Dack, Commandant of the Iowa Soldiers' Home, announced that despite the heavy demand for Health Care Services, a unit (35 beds) in the Sheeler Health Care Facility is in the process of being closed. There are 217 aged, ill, and handicapped veterans, wives, and widows awaiting admission to the Home. The greater number of these prospective Residents require the Hospital or Nursing Care bed.

Such action, following recommendation by the Administration to and with approval from the Department of Social Services, resulted from a thorough evaluation and study of the appropriations for the Home received from the Legislature for the 64th Biennium.

The Home received an appropriation for Fiscal Year 1971-72 of \$2,707,434 and for Fiscal Year 1972-73 of \$2,797,168, a 10% increase over the 63rd Biennium (or an annual increase of 6½%).

However, with increased medical costs of 10-14% yearly; yearly merit increases (5%) for employees; and implementation of the Jacobs Pay Plan (5%) for the majority of employees, the increase is not sufficient to continue to provide the present required level of Health Care Services for the Residents. A position by position projection of the present staffing pattern, together with monies required for continued operational expenditures, reveal a deficit of \$120,326 for Fiscal Year 1971-72 and \$179,729 for Fiscal Year 1972-73.

During the past 63rd Biennium, the Home, in attempting to
maintain an adequate level of
care while experiencing soaring
costs, was forced to reduce its
staff by twenty-four positions to
meet its appropriation. With in
sufficient monies for the current
64th Biennium, the Iowa Soldiers'
Home with an already reduced
staff was left with no other alternative but to bring the level

of expenditures into line with the available budget by reducing the number of Residents served. It is only through such measures that existing quality of Health Care Services can be maintained.

The present Soldiers' Home staff consists of 310 employees providing around the clock seven days a week care for 513 Residents. With the closing of unit in the Sheeler Health Care Facility, a reduction in the number of staff will noted. Approximately twenty-five positions will be lost. This reduction, it appears, will be accomplished through attrition rather than a layoff.

In comparing costs of operation of the Iowa Soldiers' Home with other State Home medical costs and like facilities such as the Veterans Administration, Dack feels the Marshalltown operation demonstrates efficiency and economy in service. For example:

During the past 63rd Biennium, through monies received from the Residents based on their ability to pay for Health Care Services at the Home and the Federal per diem reimbursement from the Veterans Administration, the Marshalltown Facility returned to the General Treasury of Iowa approximately three million dollars out of a five million budget. It is anticipated that during the 64th Biennium the Home will return to the Treasury of Iowa over 50% of the appropriated budget.

Dack is hopeful that through the understanding of the Legislature, the efforts of the Veterans Organization of Towa are most concerned, and the Department of Social Services. that the General Assembly will provide supplemental funding when they convene in January so the closed unit at the Home can be restaffed and opened. A valiant effort on the part of concerned Legislators to obtain additional funds for the Towa Soldiers' Home during the last days of the first session of the 64th General Assembly was defeated in the House 44 to 38.

The need and demand for service to Iowa's aged and chronically ill veterans is obvious. However, in order to provide the necessary Health Care Services it requires personnel, and personnel in these days of inflation cost money. Till then, those on the waiting list will have to wait longer for admission and the list will grow in number.

HARRY MALLOY RETIRES

Harry E. Malloy, Volunteer Coordinator and Community Liaison Representative in the Activities area is retiring effective October 11, 1971. Mr. Malloy has spent thirty five years of his working career in the employ of the State of Iowa serving the Veteran and his dependent at the Iowa Soldiers' Home.



He served the Home as Quartermaster for some 24 years. Then during the Administration of Commandant Ward M. Loftus, Mr. Malloy entered the recreation area in 1960 and had the responsibility of the Recreation and Activity Department. As the Department grew Mr. Malloy assumed the responsibility for coordinating the volunteers who come to the facility.

His friendliness and knowledge of proper organizations and community resources led to his responsibility of Community Liaison Representative.

The Iowa Soldiers' Home staff and residents wish Harry well in his retirement.

THE GEORGEMORTLE


