The College of Liberal Arts and the College of Business Administration offer a joint program leading to a Certificate in International Business. This program entails study of international business and economics, international relations and institutions, a foreign language, and related area studies. It has been designed not only for those students who intend to pursue careers in international business, but also for anyone who is interested in gaining a better understanding of the global economy and a broader awareness of the political, historical, and social environment in which international business operates. The wide range of electives in the program permits students to tailor areas of specialization suited to their individual interests and to complement majors in both liberal arts and business administration.

Completion of requirements (as described in following pages) will result in the notation "Certificate in International Business" on the student transcript. Certificate Requirements and Procedures

Following are requirements and procedures affecting the Certificate in International Business:

- A. The student must declare his/her intention to pursue the certificate at 121 Phillips Hall.
- B. The student must receive a degree from The University of Iowa in order to receive the certificate.
- C. A minimum grade-point average of 2.00 must be maintained on all course work taken for the certificate.
- D. At least 20 semester hours of the certificate course work (other than language) must be completed at The University of Iowa.
- E. A course may not be used to satisfy more than one certificate requirement.
- F. The student must complete the designated courses in international business, international relations and institutions, and foreign language and related area studies detailed below.
