**DES MOINES**— The Environmental Protection Commission will meet in Emmetsburg, Iowa to tour the Iowa Lakes Regional Water, Osgood Water Treatment Plant and Lost Island Lake on Monday, May 15.

The meeting starts at 9 a.m. at The Shores at Five Island, 14 N Lawler Street, Emmetsburg, Iowa. The public can also attend via video conference or by phone. ## Workshop to help communities fund redevelopment of abandoned or contaminated sites

A free, one-day workshop designed to help local communities redevelop brownfield sites on June 6 in Cedar Rapids and June 7 in Des Moines. The type of properties for consideration are where environmental contamination or concerns about hazardous materials, such as asbestos or lead-based paint in building materials, have hindered a community's interest in acquiring and redevelopment. The workshop will introduce communities to new and expanded financial and technical resources available to help redevelop these sites.

The workshop will provide attendees with information on technical and financial assistance for environmental analysis at brownfield sites, redevelopment concept planning, environmental assessment, and cleanup assistance, building demolition, and even building remodeling assistance. Financial assistance is available from \$25,000 to \$5,000,000 for site cleanup and redevelopment, subject to site and program eligibility.

The workshop is for local government officials, key community stakeholders, economic and community development organizations, not-for-profit entities, community groups, private citizens, and others working to revitalize lowa communities.

Presented by the Iowa DNR, the U.S. Environmental Protection Agency – Region 7, and the Kansas State University Technical Assistance to Brownfields Program

(KSU TAB), this workshop will help attendees understand what a brownfield is and how redevelopment can kick-start community revitalization.

- Meet brownfield redevelopment partners at IDNR, U.S. EPA, and KSU TAB and hear about the free tools and resources they offer.
- Learn about state and federal grants, including new grants from the Bipartisan Infrastructure Law, which significantly increases financial resources for brownfield site assessment and cleanup.
- Learn about additional technical assistance, site analysis, and planning services that can help them meet their brownfield site and community redevelopment goals, and see examples from lowa communities that have used these resources.

### **DNR enforcement actions**

DES MOINES – DNR staff work with individuals, businesses and communities to help them protect our natural resources by complying with state and federal laws. This approach is very effective. In the few cases where compliance cannot be achieved, the DNR issues enforcement actions. The following list summarizes recent enforcement actions. **Consent Orders** A consent order is issued as an alternative to issuing an administrative order. A consent order indicates that the DNR has voluntarily entered into a legally enforceable agreement with the other party.

#### **Butler County**

David Dohlman d/b/a Dave's Auto Repair Service

Cease illegal solid waste dumping and open burning; comply with all applicable laws in the future; properly dispose of all trade waste on site and submit disposal receipts; and pay a \$1,000 administrative penalty.

#### **Hardin County**

Allen Jaspers

Ensure that land application of manure is conducted by a certified manure applicator and pay a \$3,000 administrative penalty.

#### **Scott County**

Quad Cities Metallurgical Laboratory, Inc.

Relinquish all lab sample analysis certifications other than for certain drinking water, wastewater, and land quality samples (total coliform, E. Coli, fluoride, nitrate, pH, and metals); take specified corrective actions to maintain these certifications; and agree to and pay for regular audits.

#### **Tama County**

**Presley Bland** 

Cease illegal solid waste dumping and open burning; comply with all applicable laws in the future; and pay a \$2,000 administrative penalty.

#### Administrative Orders

Responsible parties have 60 days to appeal the order or 60 days to pay the penalty.

### Air Quality permits under review

DES MOINES – The DNR Air Quality Bureau has the following draft permits for review. The permits help protect lowans' health and the air where we live. DNR's permitting staff review the applications to ensure facilities comply with state and federal air quality standards. The public has the right and is encouraged to comment on draft permits. DNR considers <u>public comments</u> before finalizing the permits. Submit comments in writing to the assigned permit writer before 4:30 p.m. on the last day of the comment period.

#### **Construction Permits**

DNR engineers review and issue construction permits to facilities before they build new or modify existing sources of air pollution. The public may review the following air quality construction permits available online at www.iowadnr.gov/airpermitsearch OR through the EASY Air Public Inquiry

Portal and click the Public Notice tab.

**Scott County** Continental Cement Company, LLC (CCC) – 301 E Front St., Buffalo. Project Nos. 23-095 and 23-098

CCC operates a Portland Cement Plant. Project No. 23-095 is to allow the crushing and conveying system (EU 0218-1) the use of filter cake material, and Project No. 23-098 is for the construction of a newly paved haul road (2260-1-F) to accommodate the future increase in alternate fuel usage at the facility.

The public comment period ends June 20.
