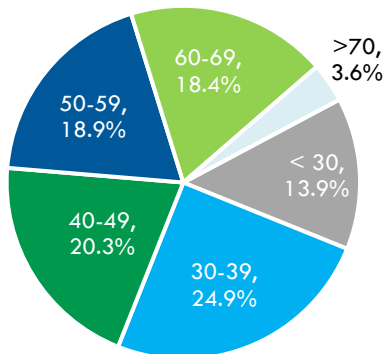

Age Range of Active In-State Nurses

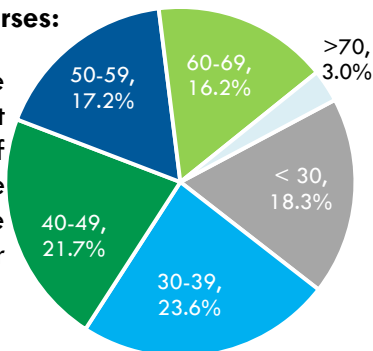


Registered Nurses:

The mission of the board is to protect the public health, safety and welfare by regulating the licensure of nurses, the practice of nurses, nursing education and continuing education.

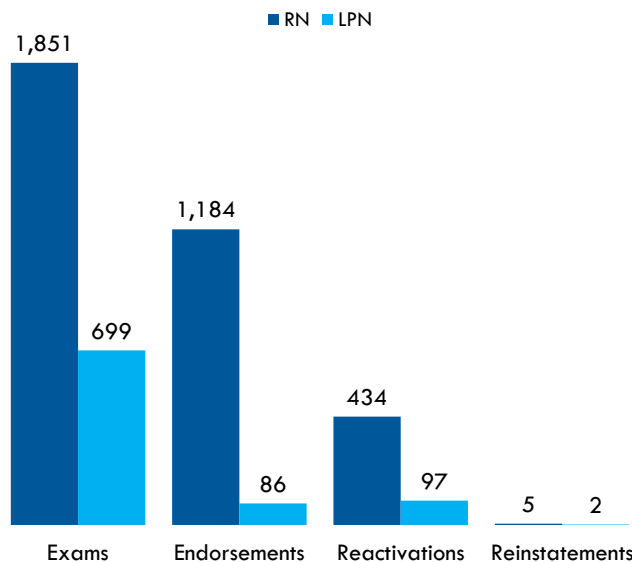
Licensing Fees

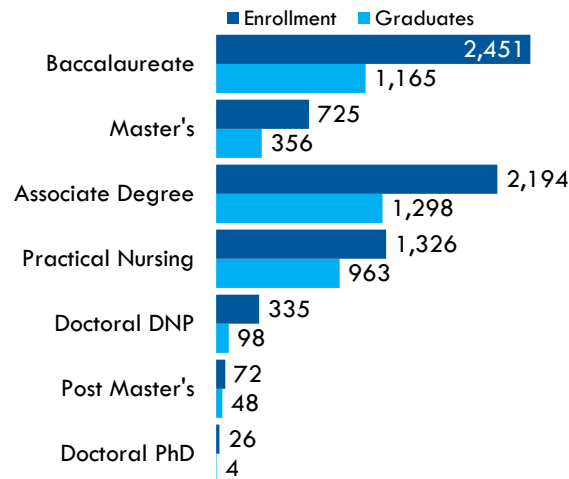
