### \$31.5 Million Dollar Impact on Iowa's Economy

The Iowa Farmers' Markets Economic Impact Study

The Iowa Farmers' Market Economic Impact Study is finished and can be viewed in full at the IA Dept. of Agriculture & Land Stewardship (IDALS) web site www.agriculture.state.ia.us

The Iowa Farmers' Market Association (IFMA) initiated this nearly \$40,000 project with grant dollars awarded from three different funding sources.

USDA National Ag. Statistics/ Iowa Ag Statistics conducted the data gathering from consumers and vendors. ISU economy professor Dr. Dan Otto, and a graduate student were hired to analyze the data and write the report.

IFMA members will be receiving a full spiral-bound printed copy of the report. Non-IFMA members may purchase a spiral-bound copy for \$25.00. To purchase a copy contact Ginny Gieseke at 515-277-6951.

A promotional tri-fold brochure highlighting the Impact study will be available soon. All market managers will be receiving a small quantity of these brochures.

Until now, there was little hard evidence showing the impact of Iowa's farmers' market industry on the economy.

The Farmers' Market Economic Impact Study provides solid information on the impact and contribution of farmers' markets on Iowa's economy.

### Final FMNP Vendor Training Session

The final vendor certification training session for the 2005 Iowa Farmers' Market Nutrition Program (FMNP) has been scheduled. All growers seeking certification in the FMNP must attend a two-hour training session. There is no cost for the training, which must be completed before WIC or Seniors FMNP checks can be accepted. The training will be effective through 2007.

# Ag Secretary visits North Iowa Farmer's Market

MASON CITY \_ A "farm girl who loves a good drive through the countryside," Iowa Secretary of Agriculture Patty Judge dropped by the North Iowa Farmer's Market in the Kmart parking lot Friday.

"Farmer's markets are a good niche, a great way for our residents to shop locally," Judge said. "Unfortunately, too many people outside Iowa think of us as a big cornfield from one river to the other."

With a trained eye, Judge wandered the booths, asking questions of vendors about produce, individual operations and state policies.

Jan Libbey, who operates a Kanawha-based produce farm, One Step at a Time Gardens, with her husband asked Judge to continue strong support of meat inspectors, critical to the farm's open pasture poultry production.

"If you are going to support small scale farmers like us, those inspectors are critical," Libbey said.

Although Libbey has had Judge's ear in the past during official meetings, "Today, she came to where I work and met my crew. This was a great opportunity for her to step into my world."

Even here, she was asked about this year's commodity crop outlook and growing season.

"After a slow start, things are looking good.

"We are right on target for another bumper crop," Judge said.
