

Part V

How This Survey Was Taken And Why

This survey represents the efforts of many starting with the first person who by constructive conversation with others having the community of Fort Madison and surrounding area as their prime concern for years to come, commenced to find out if others were as concerned as they were. The first step was in taking the concept to active organizations within the community for input and backing to insure that the survey accomplished the intent and received the necessary support of the voting residents.

Once the questions had been agreed upon by the sponsoring organizations, being the Fort Madison Jaycees and the Fort Madison Chamber of Commerce Transportation Committee, the information was placed along with the Ballot of Questions into the supporting local newspaper, the Fort Madison Evening Democrat on Wednesday, November 1, 1978. The Survey forms were to be deposited in appropriate containers at Fort Madison banks, supermarkets and/or industry. These containers were placed on November 1 to be picked up on or before November 7 allowing the five days from date of publication for the residents to return the Survey forms. On the 7th day of November the containers were collected and arrangements were made to sort, tabulate and type the results.

First, the Survey forms were sorted into two categories, resident and non-resident as indicated in question #7. (Do you live in Fort Madison? Yes No). Upon the completion of this sorting by location, the forms were counted which gave us how many voters at each collection location were residents and non-residents. This information can be found in Part I of this book.

Second, now that the Survey forms were identified as resident and non-resident, the tabulation could be started. (To take just a second, I would like to explain why the separation between resident/non-resident. We didn't feel it would be right for the non-resident to tell the resident what should be done in Fort Madison and vice-versa). In tabulating the forms, each item on each Survey form was transfered to composite tabulation forms which were once again totaled by location in order that the information would be kept in as self explanatory and usable form as possible. This information can be found in Part II of this book.

Third, the composite tabulation of residents Survey forms from the banks, supermarkets and industry were placed together in order that the total opinion of all residents could be established. This same procedure was followed on the non-resident Survey information. This information can be found in Part III of this book.

Fourth, after many long hours of tabulation, the Xi Delta Psi Chapter of Beta Sigma Phi Sorority commenced with the task of typing each and every comment made by both resident and non-resident. This was typed by location in order that the time spent by a very generous and fantastic response showed that we, the citizens of both the City and the County care and are very concerned for the well-being of our Southeast corner of Iowa.

Fifth, a grand total tabulation of all Survey forms received was compiled by percentages from the composite tabulation information found in Part II. This grand total tabulation represents the desires of the residents of the Southeast corner of Iowa.

During the last few years, our traffic problem has grown out of proportion to the place where it is very obvious to the average citizen. Realizing that there is more than one solution to any problem, we felt that rather than trying to tell someone how to solve the problem, we would ask the citizens to express their opinion on a series of questions which would allow us to place that information on a form that would indicate the citizens desires.

The traffic problem coupled with the desires of the citizens will give direction and backing to our City, County and State Officials in solving this problem and continuing the growth and development of this, our Southeast corner of Iowa.

Lets do some planning with forsight. Don't let DuPont block you in anymore. The by-pass would move more traffic aroung the city than you think. I think the by-pass is the only feasible solution to the traffic congestic problem. However I also feel that the only feasible location is along the tracks of south Ft. Madison following the river. There isn't that much that would be displaced and the people (Minorities or whatever) would be much better off and have much nicer housing than the shantys they live in now. I do not want to see a by-pass north of Fort Madison.

There would be less traffic and accidents if we had an adequate bus service. Not just a bus service, but one that could take passengers as far as Fruehauf and students to the schools. Then these people could leave their cars at home. I would.

One thing the Jaycees have failed to tell the people of Ft. Madison & the surrounding area is that the by-pass will not correct the immediate needs of a solution to the problem. Also, that past studies have shown that most of the traffic begins and ends within the city and that the by-pass will not solve this problem. The by-pass will only benefit the minority portion of the traffic that would otherwise come through the city. By not being aware of all the facts makes it impossible to answer this survey with any accuracy what-so-ever.

The highway system through and around Ft. Madison is 20 years behind the times. Cuty fathers - the council must be much more aggressive about seeing that our needs are taken care of now. They cannot stop with threats and suits by minority or anyone. All agencies of the local community must push hard for it now.

I feel the only way we can get any results toward our traffic problem is to get some political backing, like the situation was at Burlington up to this point we are just being pushed around. Some traffic lights should be installed on the present hwy 61 thru city for the benefit os local drivers, especially on hwy at HyVee. It is almost impossible to enter Ave H or Ave. L during heavy traffic.

Needed by-pass 30 years ago.

If a by-pass doesn't clear up congestion west of town, I'd change this answer. Gas taxes should handle it, not a bond issue. Perhaps a 4 lane would be appropriate from the Cove to Armour Dial.

This city is about the only city that doesn't have a by-pass and the truckers and travelers don't want to stop here. A by-pass would put all that traffic outside the city and make safer and less congested streets for the residents.

We need a light at 8th & H or 9th & H or both.

What could help what we have if people would pull to the side that they are going to turn instead of stopping in the middle of the street, it would help and stop parking on the curve. That could help the flow of traffic. I thought it's against the law for someone to do that anyway but it doesn't seem to be that way in Ft. Madison, Iowa.

Let's consider our area aor a change instead of Iowa City, Des Moines, Davenport or Cedar Rapids.

First take care of traffic on Ave. H and highway 61 - it's disgraceful and hazardous. Then after that, the by-pass. For a town as progressive as Fort Madison, it's disgusting something hasn't been done before this. A firm stand must be taken soon!

Replace traffic signals on 18th and Ave. H. Have police direct traffic at busy times around schools. Limit parking on 34th St to one side by school.

Put the highway around town, get rid of traffic.

They don't build highways through towns. That was back in horse and buggy days. Let's try getting with the times.

I would like to see a by-pass of the city just to the north of Burlington hill with a 48th St., highways 103 and possibly Hwy. 88 accessible. Work on this starting as soon as possible.

The traffic is so bad that we can't hardly get on the road or off, and something should be done soon. We should have a four lane highway, plus a by-pass around the city, to kee the traffic moving.

Expedite now

- 1. eliminate all parking on hwy 61 in city.
- 2. correct to best degree, turning radius at 35th St. 18th and L 18th and H 20th and L 20th and H.
- 3. Make 18th St. one way east bound from L to H with no parking. 4. make 20th st. one way west bound from H to L with no parking.
- 5. Widen as needed, using both sides of parking to make uniform with now widest part from 35th st to 2nd st.
- 6. Coarse Ave. H from 18th to 20th would be a new part of hwy 61.

There should be regulated traffic lights from 18th st west clear out to the Ford Co.

Anything that is done will help. This is highway and state should foot the cost.

Most communities build new highways around towns or buy up large access to insure no one needs live close to a highway. An example of the latter is the freeway in Burlington. I favor a by-pass, but a freeway such as in Burlington is acceptable.

#4 - Only if we don't get a better route. #6 - A by-pass will not relieve our present traffic flow during peek hours. The City Council should vote to pay our fair share.

Why tear the city of Ft. Madison up to put a highway through the heart of the city, which would not help the congestion. The city of Keokuk and also Burlington is by-passed by highway 61, so why not Ft. Madison?

We are about 20 years late for moving traffic in this city.

I already pay 40% of my income for taxes. If the money is used right by our elected officials, there should be enough money for highways without further taxing or a bond issue. Something desperately needs to be done about the traffic flow through Ft. Madison.

Why should the highway come through town. Why should there be a bond issue even considered by the Council, especially when the government offered to pay 90% and the State 10%. All we would have to pay for the by-pass is 10%. I think that this whole hassle is for special interest groups instead of for the people. We need that by-pass. Displace cows, not taxpaying people.

This should have been done ten years ago. What about stoplights?

They don't generally put through highways through cities, and I don't think we should.

City officials' refusal to accept proposals of highway engineers is the reason this highway has not been built. The highway department wanted to improve it 20 years ago. See what has happened in Keokuk? We want to park on the highway. I don't know of any 4-lane highway where you can park on half of it. Change their minds or change the officials.

What consideration is being given to the pedestrians? It means taking your life in your hands now to cross Avenue H to get to Riverview Park, the Museum and places of business. Also, are you considering the bottlenec created by the bridge which would only increase if the highway is widened.

Build the by-pass now. We are 15 years behind.

I would like to have some kind of transportation in our city for people like myself that don't have cars. I would like to be able to go to town at least once a month.

Please quit listening to the city father cry babies: "What was good enough for us." Progress is important and progress means change.

If a by-pass of the city is built, traffic in the city would be easier for industrial workers to get to and from work. If people traveling want to shop in Ft. Madison, they will. Most highways today by-pass cities, which makes it much easier for everyone concerned to travel.

If a by-pass is the answer, then highways 2, 88 and 103 must be improved to provide access to Ft. Madison. Re question #5 - It is a solution if a by-pass is not accomplished.

A north by-pass around the city is the answer to the city of Ft. Madison, or the 4A route.

Proponents of improving the existing highway 61 route should make a head count of the obvious through traffic units that travel the route in a given period without intent or purpose to stop within the city limits. Questioning the destination of every vehicle would provide greater accuracy, however, just the number of semis, campers and passenger cars (other than Iowa and Illinois) would confirm the need for a by-pass highway. In further consideration, it is only a matter of time before a serious accident with loss of life will occur in the area of the far west shopping facility. You take your life in your hands every time you exit from or enter highway 61 from the ever-increasing shopping and commercial units. Thanks for the opportunity to express my opinion.

Question #3 is absurd. We already pay gasoline tax for the purpose of building by-passes and road improvements. Why should even the question of a bond issue or special tax even come up? Any attempt to build a monumental 4-lane race track for highway 61 truck traffic through the heart of our old city would be to commit logistical hari-kari and would be a mortal blow to the retension of any historic values of our city and would kill our downtown commercial area.

I would like to see a by-pass build soon. Some people in Ft. Madison call highway 61 through and west of Ft. Madison 'suicide alley.' Let's do something about it.

The traffic situation into and through Ft. Madison is abominable and a disgrace for a fine, growing community such as ours. I think we should have both #4 and #6. Even with a by-pass, we would still have a traffic problem in the city. We have tolerated this poor situation long enough, so let's get on with it!

A by-pass around the city would solve any existing traffic problem for the city of Ft. Madison and would be paid for by the DOT. An example of a 4-lane highway put through a city is Muscatine, Iowa. It is terrible and they are now building a by-pass because it did not solve a traffic problem.

I think most of the existing highway 61 route is in pretty good condition. I would like to see the bad parts improved, especially the section that goes by TGY, Jacks, etc. If there is a by-pass built there will really be no need for improving the existing 61.

By-pass is the best way to go. Who needs the big trucks and through tourists bottling up our long, narrow town? If they want to come into town, they will take an off-lane from the by-pass.

Why shouldn't they by-pass around the city of Ft. Madison. They are not missing a thing by by-passing. Why don't you do something for the elderly so they can get around, and get a bus or taxi in this town. You seem to have money to spend for everything else. Do you think that some day you are going to live to be old? Did you or your wife ever walk to a grocery store and carry your groceries home? Just try it sometime. Maybe you will think what it's like and get a bus or taxi in this town. Our taxes and cost of living are going up the same as you, but we don't get a raise in Social Security like you do working, or go on strike to get it. I believe in 'Do unto others as you want them to do unto you.' Think it over.

Congestion can be relieved immediately by removal of the kinks in the present 61 such as the 18th Street turn, through local financing. Opposition by the City Council and the Chamber of Commerce and other special interests to long range relief by a by-pass for through and east to west end traffic will permit State and Federal assistance. Some form of public transportation to east and west shopping and industry areas is essential for those who do not have cars and those who can be encouraged to bus to work and shopping.

It is impossible to get on Avenue H and L during some periods of the day. We are going to have accidents and more people killed if something isn't done very soon about the traffic problem. Why hasn't the city done something before it got so bad?

Re question 3 - I feel that the town of Ft. Madison already has in their funds and plus the funds of the State, that we shouldn't have to pay for a bond issue or a special tax to pay for am improvement of the congestion of traffic.

Traffic congestion on Avenues H and L is terrible and gets worse all the time. The State proposal should have been accepted by the City Council. The traffic problem is critical.

Traffic tieups in the TGY area as well as on Avenue H could be eliminated if the highway were rerouted around Ft. Madison.

Present highway 61 route through the city is basic cause of 98% of congestion problems. Through by-pass arrangement. Financed via road (State/Federal) tax system.

Extend 48th Street from Avenue L to the Bluff Road. Also Crescent Lane, which is all paved except for about 100 feet.

I live on the present route through the city. What we need is a by-pass about five miles out to the north of town. Let us keep our peaceful little city to itself. Bigness is not necessarily goodness or greatness. Quality of life in our town should count for more than dollars from tourists.

Do something before some people get killed.

With 4-lane improvement of the existing highway 61 route, you are taking the parking area of property, thus bringing traffic closer to homes, reducing the value of property and in some instances endangering lives. Our backyard is already useless to us as it is hardly useful for cookouts in the summer with cattle trucks going by and constant emission of diesel fuel.

A by-pass of Highway 61 to the north of Ft. Madison should have been made a long time ago. I never could understand why the city fathers kept pushing for it to continue through the heart of Ft. Madison, a narrow valley lying between the hills and the river, when always the large majority of its citizens have wanted it to by-pass. Increasingly other cities are trying to get rid of in-town highways. So why should we, instead, keep trying to get ours enlarged, thereby destroying many private and commercial properties by chopping off their frontages or destroying their property completely? Any thinking that it would help the economy here has been proven to be wrong. Many years ago the Evening Democrat carried an item saying that contrary to what had been heretofore thought, by-passing of cities with highways had been found to improve the economy of cities, through the building up between the highways and the city proper. Also, it has become increasingly more dangerous to have trucks passing through towns because of the dangerous materials often transported by them. Living in the east end of Ft. Madison (2 blocks from highway 61) I am aware that those who live in, or have businesses in this area, are very vulnerable what with three modes of transportation going through (trains, barges and trucks-and-autos), all of which apparent ly carry dangerous substances. We were lucky that the overturned train at the bridge recently was carrying nothing dangerous, thus necessitating a quick evacuation by at least us east-enders. Highway 61 would have been impassable for a long time, judging by the experience of such catastrophes elsewhere. And they are happening more frequently. So this convergence of several types of transportation along this vale (of fears?) presents real hazards for this crowded area, and even the whole area. Furthermore, we hear now of how small children are getting lead poisoning from the polluting of the dirt, etc. by heavy traffic through their neighborhoods. Please, let's give the same concern to the hazards on the outside as is now being given, enviornment-wise, inside the industries all about us.

This traffic problem didn't happen overnight. Someone should have been working on this ten or fifteen years ago.

I think far too much money and time has been spent on the highway project with nothing being decided. We should by-pass Ft. Madison. Anyone wishing to shop in Ft. Madison can use the route for that purpose, but travelers wish to continue on their way.

With a new development back of Madison Baptist Church and at Hillview Village, it is imperative something be done at Avenue L and highway 61. After 3:30 p.m. it takes 15 to 20 minutes to go from 23rd Street to 41st Street. If we go the other way (east) we have to cross the cemetery to get on highway 61. This is not a through street.

We have local traffic problems which the local authorities could correct if they would. Illegal parking, speeding, stop sign violations, Should have one side street parking on the narrow streets - if it passed Council action and was actually enforced. In other words, all of our traffic problems are not necessarily route 61.

We need a by-pass very badly. When we travel to other places, we use the by-passes unless we have a specific reason to go into the city. Local merchants do not benefit from cross-country traffic.

We may not need an extension once we get 61 traffic out of the city.

I would very much like to see something done about the parking on both sides of narrow streets here in the city of Ft. Madison. Some cities have parking only on one side to allow more room for passing cars. One city I was in had parking on one side of the street on even numbered days and on the opposite side on odd numbered days of the month. There were times last winter when driving was especially hazardous due to accumulation of snow left along sides of streets when motorists left cars standing and the plow had to plow around these parked cars. Shouldn't there be a winter parking ban?

Ft. Madison is the only town in the area without a by-pass. With Keokuk and Burlington more progressive than we are, why would anyone in their right mind come here. It is downright disgusting to have such a bunch of backward people holding up such progress. What will our new industries think of the town?

We could use a by-pass, but only after we eliminate the congestion problem in the city first.

Please consider building a by-pass to the north of town. We do not need through traffic in town. Can you promote some city bus service?

If there is a by-pass built around Ft. Madison, we won't have to have a bond issue or extra taxes. They have fought over this by-pass for at least ten years and I think it is time to settle this road arguement without tearing up the streets in town. I also think it is a disgrace that the town of Ft. Madison has no buses.

Enough of our highway taxes have been spent around Des Moines, Ames and Iowa City. I think that it is time we get some good of it in southeast Iowa.

Should use the proposed south route. It must not go north of the city. South route originally held up by 5 families?

Do it now.

Speed up slow drivers.

Does the City Council need to be told about question number six?

If something isn't done soon, we're going to be faced with fatalities.

Use the south route along Burlington Northern tracks -- shy? Should all of Ft. Madison suffer and loose out because of misplacement of 5 families.

Use the south route along the tracks. Do not go north of town. We'll die like other by-passed towns have.

Use south route for detour or by-pass.

If you wait any longer to get the 61 muddle straightened out, it will cost more and more. Had you done this before when you first started, it would have been at least one-third cheaper -- taxpayer's money.

Do something about more traffic lights at 27th & L, 15th & H, 35th & L.

It's high time something is done about the traffic problem on Avenue L. This should have been done 20 years ago. Now it costs 3 times more.

A light or other form of traffic control should be erected at Avenue L where the highway comes into the city. There is often a wait of ten minutes or more for Avenue L traffic to continue east.

The town of Ft. Madison does not get its fair share of Federal money. I think we should get enough Federal money to take care of this problem.

It's about time. It's too dangerous.

We need a by-pass around this town badly.

Use south route for by-pass.

If the City Council would have enforced the law of no dead end streets in Ft. Madison, we wouldn't have some of the problems we have. Instead of building a by-pass around Wever and Ft. Madison, why not incorporate it all into one and make it sweep around Ft. Madison and go between Ft. Madison and West Point and bring it out up by the junction of Highways 61 and 16. It wouldn't be costing so much if you would have done this 10 years ago and built a by-pass, instead of fighting between the City and D.O.T. It costs us taxpayers more money when the City guys go to a meeting with D.O.T., whether you go to them or they come to you. Get your stuff together and build a by-pass now before inflation doubles the cost of what it is now.

The D.O.T. has given us the wrong kind of run around much too long.

Make Avenue E a one-way street east. Straighten the Bluff road to alleviate much of the traffic traveling from southwest Ft. Madison to the north central sections. I think even taking parking off Highway 61 and making special lanes for turning left and right would help the traffic flow.

To go west, it is use the highway or stay home. If you live south of the highway, add 1/2 hour travel time each way to work or store.

We need a by-pass, and 4-lane from the junction of highways 2 and 61 West, to 2nd street, at the Santa Fe Bridge. But, also I think that the major portion should be relocated to the south of the present route from 38th to about 10th Street.

From what I understand, a by-pass around Ft. Madison would be an immense help. It will provide through traffic as an alternative to driving through the City and also would provide a second route for local traffic. Highway 61 through town is drastically in need of traffic control and regulation. The only place possible to make a relatively safe entrance onto 61 is at the intersection of highways 61 and 103.

We need stop signals on Highway 61 at Avenues H and L for access from a few side streets, preferably 15th, 10th and 23rd.

I live on the east end of Ft. Madison and work in Keokuk. It takes 45 minutes to get to work, fifteen of which is spent getting through town. Anything would be an improvement, preferably a by-pass.

The answer to #6 could be no, depending on the extent of the proposals for #5. The highway situation in Ft. Madison is a joke. Something should have been started years ago. The biggest bottleneck on Highway 61 between St. Louis and the Quad Cities is Ft. Madison, Iowa. That's ridiculous for a town of only 15,000. Every time a new business or industry locates on the west end, the problem gets worse and worse. I answered yes to all questions because I feel that eventually all of the mentioned options will need to become realities. The obvious place to begin, however, is on the existing Highway 61 route.

Something should be done about the corner at Avenue H and 2nd Street. So many persons work in our surrounding factories, it is hard for those going to Burlington, etc. At least that part of Highway 61 could be re-routed.

I think the highway should by-pass Ft. Madison to get trucks and thru traffic out of the city. Also, when they started planning where to build the highway, the D.O.T. said within 5 to 10 years it would be necessary to by-pass our city. They have been planning now for 5 years and traffic has increased, so why waste more tax dollars to build through our city.

The traffic situation on Highway 61 is ludicrous and would have been alleviated long ago by the State in the form of a by-pass if the downtown merchants had not interfered in their desperate quest to force people to shop in Ft. Madison. The downtown merchants need to face reality. People don't shop there, regardless of the highway solution because the selection is poor, prices are not competitive, and service is non-existent.

By-pass.

Why is the Government so tight with our money? Why should we pay twice?

As an Avenue L resident, I would encourage a by-pass. East end residents would use east end exit and west end residents would use west end exit. Ridiculous to consider routing highway through the city. All new highways by-pass towns, especially long sprawled out towns such as our own.

I would like something done about the dirt roads.

If a four lane highway is built through town on the existing highway 61 route, pedestrian over-passes will be a must. Also, all the traffic in the world is not going to help the downtown businesses. We should improve the existing highway to 4 lanes:

If I were a truck driver I would hate to drive through this town. Those turns from Ave. H down 18th & Ave. L are hazards.

We are paying for it now. The have a freeway in Burlington to relieve congestion.

All your congested Ft. Madison traffic is from the city. If believe it would really help if we have a two lane road from East end to west end and a two lane roal from West end to East end. If the present highway is made into a 4-lane highways, the traffic will be practically on the front porches of persons living along the highway. Yech.

Let's get with it and follow the states recommendation as soon as possible.

Do something. Even is it's wrong, do something.

Traffic is bad on Ave. L from 3 p.m. on til 5:30 especially. Impossible to make a left turn so mamytimes I turn right and weave back on other streets. This doesn't conserve gasoline.

Traffic control is needed at the intersection of 38th Place (south of Du Pont Co) and Avenue L. This intersection is dangerous during the rush hours. Access road from intersection at Hy-Vee west to Jim Baier Ford, both north and south of Highway 61. Traffic control needed at Busard's Trailer Court during rush hours. Need traffic control at two to four block intervals on Avenue H from 4th Street to 18th Street to allow entrance from both north and south side streets. Please do something to relieve the traffic problems on Highway 61 before some people are killed.

We want the traffic out of Ft. Madison.

(Re #3) Let the trucks pay — they're the ones who tear up highways so badly. The railroads maintain their routes of travel, so if the trucks use our highways, they should maintain them.

Four lane through town with no parking, left turn lanes about every four blocks, and no stop on right turn signs. Provide parking for residents by cutting in space to sidewalk if desired. (See what John Naifeh has in front of his store, or go to Denver and see what is done on streets there.) Keep traffic speed up, and put frontal roads in west end of town.

(Re #3) Depends on how much. (Re #5) Do not feel a by-pass would hurt Ft. Madison business district.

Being that the traffic problem is a hassle, something should be done and right away, before it gets any worse.

I would like to bring to your attention the current situation involving traffic flow at the intersection of Avenue L & 26th Street, concerning the inappropriate use of the pedestrian crossing signal. I consider allowing the general public to determine at their own opportunity to obstruct the free-flow of traffic through this area a large detriment to the City of Ft. Madison and their attempts to correct this congestion of traffic. We definately need a by-pass around the city of Ft. Madison. Also, more than one through street exiting from the city to its outlying industrial areas. Avenue E is also a highly congested area in need of wide ingor some similar type of relief. (Re Question #3) I feel that enough money has been paid out through the taxing of gas to more than compensate for this badly needed improvement without introducing yet another bond issue or special tax.

Get it done and quit fooling around before the cost goes any higher.

Highway 61 West of Ft. Madison should be wider and have no shoulder. There should be a road between Jacks and TG&Y, so you wouldn't have to come out on 61.

(#4) Only if by-pass doesn't go through.

More roads or by-passes are not necessary if existing roadways are widened and parking prohibited to make room for turning lanes.

The state should build a by-pass like they do everywhere else.

(#5) Only if it doesn't raise taxes. We certainly believe the highway should by-pass around the city.

With the amount of traffic on the highways, it would be best to by-pass Ft. Madison. The west limits is really a congested area and is unsafe. I don't believe it would hurt the business here at all. It didn't seem to bother the Keokuk business with a by-pass.

Just get on the truckers' CB. They hate our city because of being held up. A by-pass cannot hurt the downtown. It's already dead. Just go to Burlington at the shopping centers. All of Ft. Madison is there.

If the city would plan ahead, this trouble with streets through town wouldn't have happened. For instance, Richards Drive, Oak Drive, Melody Terrace, etc.

I see what Burlington has done in the last five years, and I have seen what Ft. Madison hasn't done in the last 20 years with their highways, and it sort of makes me ill.

Improvement of the existing route 61 would be too disruptive.

The by-pass is positively necessary. (To lessen the traffic congestion and ease the traffic flow.)

The solution is a by-pass. The statement by D.O.T. representative re "All traffic begins and ends here" is stupidity. This is the case wherever one lives. I suggest the D.O.T. listen to the majority, rather than a few in the Chamber of Commerce. Ask any trucker about Fort Madison. Make highway 61 into 3 lanes with the center lane only for left turns and round off the corners at 18th st on H & J.

I would be (referring to #3) but since I live in Montrose and not Fort Madison I don't see that would be possible.

A bypass of 61 north of Ft. Madison would be the best solution to the traffic problem as the city streets are too narrow for a four lane. If we bypass Wever which is only 5 blocks and Fort Madison about five miles, what could be wrong with a bypass. We do business in Fort Madison and the by-pass would not stop us from going to Fort Madison, and I think it would cost less in the long run.

If you have a bypass around the city for trucks and traveling cars, the farmers and other people can get in town to do some business & shopping.

I believe a by-pass around the city with interchanges would eliminate a lot of congestion. Not everyone going on 61 is stopping to shop. Why can't Ft. Madison become modern like so many cities throughout the U.S. with by-passes. We live north of Montrose & my husband works at the Prison, so he travels 61 nearly 6 or 7 days a week.

Ia a by-pass around the city of Ft. Madison was built, I don't think the traffic would be heavy enough to warrent the city building other streets past the far west end shopping district.

Being I don't live in Ft. Madison, some questions I'm leaving blank, but #4 if this is 138,000 some they are going to do from Wever to Ft. Madison I don't agree (everyone to their own). My opinion, I'd rather see them paved the road from Lowell to the Geode Blacktop, especially across the dam. That gravel road is used a lot and all the pit holes are bad on vehicles. They are always putting gravel on then tar or sap or what ever they use which doesn't help either.

A traffic signal is badly needed at 48th & hwy 61.

Extended streets would help in getting to shopping districts but by-pass would be better for highway traffic.

If I were a resident, I would vote yes for both 3 & 5.

All Lee & Des Moines county residents will back item #6, yes. (typists note this was signed by 14 different persons).

Present traffic problems are caused by thru-traffic in general. By-passing the city would make it safe and convenient for local traffic to use the city streets without the annoyance of semis, etc. I'm sure thru traffic would also have a friendly word for our area too if they didn't have to battle the present situation. Besides, the river-route improvement sounds horribly expensive and only a second-rate solution.

Should junction with proposed 518 west of Ft. Madison.

There is simply too much traffic with only one way to go on one road (the highway). The highway itself is at best in a deplorable condition. I lived in Ottumwa, a city over twice as large as Ft. Madison but it only has half the traffic mess.

Anything other than a by-pass should not even be considered. We live in the Donnellson area and because of the congestion, we shop mostly in Keo.

A by-pass would be the best and most feasible solution.

Lee County Savings Bank

With the way the highway is now it is dangerous and people have to take chances to get on or off the highway. The speed limit is 30 mph but it is so congested you do good to go 20 mph.

I drive to Ft. Madison every day but I do not shop here because it is so difficult to get onto the main streets. I live in Nauvoo and usually prefer to shop in Keokukor Quincy.

Traffic moves faster in rush hour in chicago.

I shop in Ft. Madison and it is not safe for people over sixty. I have pulled a travel trailer 20,000 miles and I never ran on to such a bottle neck as Ft. Madison It looks like to me that some body wants it that way. The children that have to cross 61 highway, it is terrible. And old people that have to so there shopping (grocery) on foot or car have a real problem.

Let north bound traffic on 61 go. 18th and Ave. L stop south bound, this will allow a flow of traffic without worring of who will turn south bound or go on 18th.

My main business is in Ft. Madison. My property tax is over \$700.00 now. That is more than i can afford. If more extended streets, it would be Ave. L which help is it were to the north of the shopping center.

Its seems there is an extremely large number of County. City, vehicles on the roads and streets at peak load periods. I'm not counting school busess, police, or farm equipment. Now if these maintaines back hoes, etc and Union Electric, Telephone, and North Central utilities chose a different time to be on the road than when people were going to work, I think traffic would be cut in half or at least move faster.

I see no reason why it should go through Ft. Madison. I'm like most people I hear talking, cannot see why the C.C. and other Ft. Madison official want it through town. You can travel all overthe country and never go through the city.

We need a by-pass and four lane through this city.

I live 3 miles north of Ft. Madison but because of Ft. Madison traffic tie ups I shop in Burlington usually.

I live on the east side of town while Burlington is further away-I prefer to shop there rather than put up with the traffic problem in Ft. Madison.

We hardly ever shop in Ft. Madison because of the hassle with the traffic and we live in Niota, Ill.

We live on the proposed new 4 - lane north of Ft. Madison. At a meeting almost a year ago we were promised that it was only a study. Then a couples of months ago we read in the paper that it was all set. The property owners have been treated rather poorly. I think the DOT has used us a pawn to get Ft. Madison to so what they want to improve Highway 61 through town. No one at the February meeting was is favor of the plan. We all wanted a 4-lane by-pass. We, as property owners, are now in limbo. We like living here but we don't want a 4-lane highway in our frontyard. DOT plans to build us an access road in our backyard. I am very dissappointed with the DOT and would place very little faith in them. You just cna't trust them.

Above all I don't think the property owner should stand all the expense. Taxes are definetly to high.

Its too bad a very small group of people can deny alot of citizens the opportunity for improvements. I know a trucker who crosses the river at Keokuk and drives up the Illinois side to avoid Ft. Madison. It's time to improve Highway 61 and avoid all those miles of "city" driving. I hope all subscribers take advantage of this ad and express their opinions.

I live in Donnellson and have driven to Ft. Madison for 25 years to work. The moving traffic situation is bad and getting stedily worse. There are numerous traffic bottle necks throughout the City, however the worst now is the school traffic lights which halt traffic. Especially bad is the 33rd st and Ave. L. It doesn't make any difference what time of the day it is traffic is heavy at all times. Something should have been done years ago.

There should definitely be a by-pass around Ft. Madison. I live just two miles outside of Ft. Madison and work in Ft. Madison and what a mess. Thats why I go to Burlington or Keokuk to shop.

In the last two years we have traveled from the Minnesota Broder to the Golf of Mexico and from Easter Illiniois to Colorado and Wyoming and have not found any city hard to get thru as Ft. Madison.

I live in Donnellson and work at First Miss. I hve been driving through Madison twice a day for 10 years. You can't stop at a store in the evening for the traffic. #6 is very much needed.

When 2 semi's meet at 18th & L, they cannot make the corner unless one stops on 18th st. till the other makes the turn. There are so many wrecks from Hardees west to rt. 2 - we need a business road but our car dealers expand clear to the road. Don't know whether they are within or outside the city limits.

I work in Fort Madison and route 61 through town is a disgrace.

The city of Fort Madison is a nightmare to get in or out of. With all the new industry & motels, stores along the highway, you risk your life each time you enter or leave the city. You need four lanes & a by-pass BAD.

I go to Keckuk to do most of my shopping even though I work here. I ride in a car pool from Montrose and it's not worth fighting traffic to come back and shop.

Living on Hwy 61, I see daily the need for a by-pass, the sooner the better. Burlington and Keokuk built by-passes years ago. Burlington's was built in the path of the expanding city and has already become necessary to improve. I hope Fort Madison doesn't spend money on an "Improved" road thru town and have an obsolete road before it is completed.

I work in Fort Madison and drive here every day. Traffic is my biggest headache.

We live only 8 miles aeay in Denmark. My spouse works at Armour-Dial so at least one of us has to drive thru that mess every day - twice a day.

When building new highways, the modern method is to by-pass towns and cities.

We live in the country south of Ft. Madison. I would like to see if nothing else off highway roads in the TGY, HyVee area and possibly a stop light by Jack's corner. The cars & trucks to so fast thru there. Thank you for this survey.

With the truck traffic so heavy thru Ft. Madison, it would not be feasible to use the existing route. If people want to trade in Ft. Madison, they will exit from a by-pass. If a by-pass was built around the city, it would reduce the flow of traffic by 50% on the existing route.

Avenue E should be parking on one side only from 61 West to 20th street

I just moved out the city of Fort Madison because of the way people drive in this town they are all nuts.

Something should be done about the fact that the school children get get out about the same time as Sheaffers. It's very dangerous for those children.

A by - pass around the fity could well been about finished if a few business people would of went ahead and agreed to it several years ago -- but no a certain number of people try to run everything -- they want everything their way so they can stick a few more dollars in their pocket. Trucks aren't the only ones going on thru city (what's there to stop for?) there's salespeople, people going to job outside city, people on vacation. The city is one big bottle neck and about the worst in state. Thinks its about time we get off our rear and do what DOT recomend. We pay our gas tax - why should there be a bond issue or special tax. That's unfair.

I live in Montrose but have to travel in the Ft. Madison every day to work.

It takes longer to get through Ft. Madison than it does to drive to Keokuk.

The congestion at the Fruehauf plant is terrible. They need to put more exits or an access road before someone is killed.

I work in the east end of town and it's pure Hell trying to get back and forth.

Just from McDonald's West to Junction #61 & #2. We need to do something about the one route before we take on other projects.

It takes to long to get from one end of town to the other. Its dangerous driving and also the streets are too close.

We live in Missouri and it really is a hassle getting in and out of Ft. Madison. I Think it would really take a lot of traffic off of narrow streets. It wouldn't hurt business in the city because we stop twice a week for groceries and shopping.

This towns future growth is seriously inhibited due to the poor traffic flow.. I work in the city and it is really rough getting here.

If there was a by-pass the large trucks could miss Ft. Madison and thus stop a lot of congestion. I'm sure the drivers do not enjoy the long slow trip into the town.

If a by-pass would be built, probably half of the esisting traffic would go on around the city.

Think its time city of Ft. Madison wake up and get on their feet and go along with DOT. We pay our taxes. I think we are entitled to a little of it. We don't need a dond issue or special tax - already taxed enough. Come on council and businessmen quit wanting everything your way. If people want to shop in Ft. Madison they will - if not they go else where -- they always have. Don't use that as an excuse. Use to get to work in 15 or 20 min. -- now it takes 30 or 35 min.

The by-pass should have 3 good access arteries to Ft. Madison -

- 1. One at the east present Hwy 61
- 2. One at either 15th or 18th St.
- 3. One at the west end at about 40th St.

The by-pass should not be too north of the city - within 2 miles of Avenue H.

I live in Donnellson and get from work to city limits takes longer than from city limits to home.

The highway department is presently rebuilding Highway 2 to the west and is planning to at least partially rebuild Highway 61 to the north bypassing Wever. With these two modern Highways converging upon and passing through Ft. Madison coupled with our decaying downtown area the highway department should purchase and raze the downtown area and replace it with a clover leaf.

There should be some way to get from the edge of Ft. Madison to the downtown area without all the traffic hassle there is now. I feel that the people would shop more in the downtown area if it were more readily accessible. If you live on the outer edges of Ft. Madison it takes less time (and less traffic) to get to keokuk or Burlington. Also there needs to be an access road to the shopping area with Jacks, etc. Day by day it gets more and more dangerous - there is just too much traffic to make left turns or try to get back onto the highway.

If improved, I wouldn't have to take 25 mins. to get in and out of the town. Plus the school should be dismissed earlier or later so it won't interfere with traffic at 3:30 to 3:45.

I would like to see better traffic control at the shopping center's that come out on the highway and a pedestrian crossing for the people who walk and those who visit the town who are staying at the motels. The traffic lights are badly needed at the above places.

We work in Ft. Madison and get into heavy traffic both morning and evening.

I drove from 4th street to T.G.&Y. Friday after 4:30 P.M. and will not do it again until there is a decided improvement in handling traffic. Fort Madison is second only to St. Louis in handling (or lack of handling) this traffic problem. The problem should be corrected now.

I work and shop in Ft. Madison. I would appreciate improvements.
