Annual Benefits Open Enrollment for 2024 Starts October 2

The Open Enrollment period for 2024 benefits begins Monday, October 2, and runs through 6:00 p.m. (CST) on Friday, November 3, 2023. Employees will receive directions and resources by email in a special edition of the October *HRExpress* newsletter on October 2. The Open Enrollment process will take place in Workday.

If you take no action during the Open Enrollment period, your 2023 benefit elections will automatically roll over for 2024 - **except** for healthcare or dependent care flexible spending accounts (FSAs). Employees **must** re-enroll each year to participate in either FSA plan. Even if you don't make any benefit changes, employees are encouraged to take this opportunity to review and/or update your beneficiary designations.

New Expense Hub Now Available

A new Expenses Hub is now available, which centralizes expense tasks and reports to help employees address pending expense actions quickly and easily. From the Expenses Hub, employees can access tasks to create expense reports, spend authorizations, and travel-related payment elections.

The new hub displays certain "cards" when payees have expenses to address. Each card includes a link to a related report, such as:

- Spend Authorizations to Submit
- Expense Reports to Submit
- Transactions to Expense
- My Cash Advances
- My Expense Transaction
- My Spend Authorizations



Getting Traction on Slips and Falls

Just as tire traction is critical to keeping your vehicle on the road, footwear traction is critical to keeping you on your feet.



Tire manufacturers use different compounds to affect how flexible a tire's tread is. In addition, the tread pattern helps determine what part of the tire comes in contact with the road. The more contact there is, the better traction you'll have.

Footwear works very much the same way, with patterns on the soles made from various compounds. Some are more flexible and others are rigid. Some have complex designs and some are extremely flat. The flexibility of the sole will affect traction and how it performs as conditions change on the walking surface. Similar to a tire, the more tread pattern on the surface, the better traction you'll have.

What else can affect footwear traction?

Footwear traction is affected by speed of walking and weather conditions that impact the walking surface. If the walking surface is compromised, slow down and keep your sole as flat as possible to increase the amount of tread on the surface. As footwear ages it is important to evaluate the tread on the sole. As the tread flattens or the sole is worn unevenly it may be time to consider new footwear.

When conditions are particularly slippery, you may consider using additional foot gear such as cleat type devices or specialized footwear with additional tread.

Are you preparing for retirement income?


