This report reflects the percent and per pupil amount, based on the September 1988 Certified Enrollment of each school district's revenue account, to the total operating fund revenue. The information was obtained from page 3 of the 1988-89 Secretary's Annual Report.

Attached is a list of school districts that are Whole Grade Sharing either by (1) one way, (2) two way, or muliple plan.

FOOTNOTE: Due to many districts sharing of whole grades during the school year, it became evident that ADM could no longer be used in calculating revenue per pupil. The total loss of ADM for some districts and an increase ADM of receiving districts distort the revenue per pupil with no appreciable loss of total expenditures.
