Advocates Circle

In Iowa, it costs an average of \$1,800 for one child to have a CASA volunteer for one year; on average, it is \$850 for a volunteer Foster Care Review Board (FCRB) to review one child for one year. While Friends of Iowa CASA and FCRB have made progress towards serving every at-risk child in Iowa, we still have work to do.



Trainer's Corner



For FCRB Members & CASA Advocates: Continuous Learning to Expand Advocacy Skills

In the child welfare system, policies are updated, programs change, and new laws are enacted that can impact the system and the efforts we provide as CASAs and FCRB board members. Our goal is to be as effective as possible in our specific roles as we advocate for the best interest of children and youth and make recommendations to impact and improve their lives. One strategy that supports that goal is to be provided and participate in continuous learning opportunities that will enhance our knowledge and skills. Ongoing training can help volunteers reach their full potential in advocating for the specific needs and issues on a case.

The ICAB Training Program can help with your specific training needs!

The ICAB training program's goal is to effectively support volunteer's learning needs. As you consider the issues on the cases you are advocating for and the tasks you are asked to complete respective to your program's role, what training topics will assist you the most? Volunteers share their training needs with us via program surveys, in-service training evaluations, emails and conversations with their Coordinator or State Trainer, or in conversations with their CASA Coach. Based on the feedback we receive; we build our internal ICAB training library and seek out speakers to provide statewide or local training and share local live training opportunities or virtual webinars hosted by other organizations.

Volunteers are encouraged to enhance their learning journey by requesting one of our independent studies from their local coordinator or the state trainer or request to participate in a live, instructor-led session, watch an on-demand webinar hosted by other organizations, or

register for one of the upcoming monthly State Office Speaker Sessions. Check out these <u>past</u> <u>speaker sessions</u> that are available as webinar recordings that you can request at any time.
