### Children Reviewed

The cases of 1,099 unique children were reviewed from 52 counties.

Some children's cases are reviewed more than once in the fiscal year. The reviews conducted involved 1,696 children.

#### **FCRB Reports**

1,166 reports were filed with juvenile courts and provided to HHS and other interested parties.

99% of the reports were filed in accordance with Iowa Code timelines.

### **Our Volunteers**

132 volunteers served on 26 boards to review cases of children in foster care.

### Volunteer Commitment

FCRB volunteers collectively gave 9,944 hours of their time, driving a little more than 15,000 miles, to serve on local boards.

### **Volunteer Development**

FCRB volunteers logged 1,590 hours towards pre-service training and continuing education to remain current on child welfare practice and laws.
