Looking Ahead for 2024

Advocates Circle - In Iowa, it costs an average of \$1,800 for one child to have a CASA volunteer for one year; on average, it is \$850 for a volunteer foster care review board to review one child for one year. While Friends of Iowa CASA and ICFCRB has made progress towards serving every at-risk child in Iowa, we still have work to do.
