Pm-605 January 1975 Forests and woodlands provide many benefits to lowans and their visitors. Iowans earn millions of dollars each year from the harvest of timber and the manufacturing of wood and wood fiber products. On steep slopes and ridgetops, forests prevent erosion of soils and subsequent pollution of lakes and streams. In addition, forests provide habitat for a wide variety of game and non-game wildlife; they provide a pleasant environment for many recreation activities such as hiking, camping, picnicking, and hunting; and they add a great deal of beauty and diversity to the lowa landscape.

To encourage proper stewardship of these woodlands, the Iowa Forest Reservation Laws provide that forest land which meets certain criteria may be assessed for tax purposes at \$4 per acre.

For land to qualify as a forest reservation it must satisfy several criteria:

### Size of Forest

The forested area must be at least 2 continuous acres in size and not less than 66 feet wide (except where trees are growing along a ditch or gully to control erosion. In such cases, any width will qualify providing the total forested area is at least 2 acres). No ground on which farm buildings stand will be included in the forest reservation.

## Number of Trees Per Acre

Each acre of forest reservation shall contain not less than 200 growing forest trees. Areas containing less than 200 trees on each acre can be placed in forest reserve if the owner agrees to carry out certain practices such as tree planting which will assure a minimum of 200 forest trees on each acre within 2 years after the area is designated a forest reservation.

## prest Tree Species

For the purpose of establishing a forest reservan the following shall be considered forest trees: h, black cherry, black walnut, butternut, catalpa, offee tree, elms, hackberry, hickories, neylocust, Norway and Carolina poplars, ulberry, oaks, sugar maple, cottonwood, soft mae, Osage orange, basswood, black locust, Euroan larch and other coniferous trees, and all other rest trees introduced into the state for experimenpurposes.

Owners of artificial groves surrounded by a proctive border of willows, boxelders, or poplars not ore than 2 rows wide may count these trees for a purpose of meeting the minimum 200 forest tes on each acre.

Owners of artificial groves in which boxelder has en used as nurse trees may count these trees for a purpose of meeting the minimum 200 forest es on each acre providing the number of nurse es does not exceed 100 trees on each acre.

# vestock

No cattle, horses, mules, sheep, goats, or hogs e permitted on forest reservations.

# mber Harvesting and Removal

Not more than one-fifth of the total number of es in the forest reservation may be removed in y single year, unless the trees die of natural uses. When the number of trees in the forest rervation falls below 200 trees on each acre as the sult of such harvesting or natural mortality, the yner shall within one year restore the number of es to not less than 200 trees on each acre by natever means necessary.

# dministration of Laws

Forest reservations are administered by the unty assessor. All inquiries and application for a rest reservation should be made to the county asssor's office in the county in which your forest operty is located.
