Update on mpox in Democratic Republic of Congo

Transmission of clade I mpox continues in the Democratic Republic of Congo (DRC), as the largest outbreak in the country's history remains ongoing. Clade I mpox is considered to be more transmissible and can cause more severe infection than clade IIb, the clade linked to the U.S. outbreak that began in 2022. People in the U.S. who have already had mpox or are fully vaccinated should be protected against mpox. Casual contact, such as might occur during travel, is not likely to cause the disease to spread.

To date, no transmission of clade I has been noted outside of central Africa. While new clade IIb mpox cases continue to be identified in the U.S., there are no clade I cases in the U.S. at this time.

CDC has notified Iowa HHS that Iowa is among the top ten states for the DRC diaspora. Health care providers should continue to contact CADE at 515-242-5935 if they suspect mpox in a patient with recent travel to DRC or a patient who has been in close contact with someone with consistent symptoms and travel to DRC.

Health care providers who suspect mpox in a patient without a connection to DRC can continue to utilize PCR testing at SHL with no preapproval required.

Join the Iowa HHS Health Care Associated Infections (HAI) Program on Tuesday, April 30 at 12 noon for a free webinar, *Optimizing Dental Antibiotic Prophylaxis: Guideline Adherence and Patient Safety.* This course will explore current guidelines and best practices for prescribing prophylactic antibiotics, including the discontinuation of clindamycin and quinolones, with a focus on optimizing patient care and minimizing the risk of harm associated with antibiotic misuse. Participants will gain a comprehensive understanding of dental antibiotic prophylaxis, and leave with the knowledge, resources, and decision-making skills necessary to optimize patient care while minimizing the risks associated with antibiotic prescribing. At the conclusion of this webinar, participants should be better able to: identify current dental prophylactic prescribing guidelines, including discontinuation of clindamycin and quinolones, discuss potential harm to patients surrounding antibiotic prescribing that is discordant with guidelines, and review resources and clinical decision-making tools to help guide prophylactic antibiotic prescribing.
