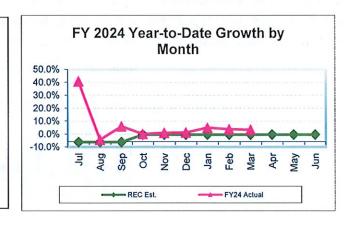

March 2024 General Fund Receipts

Gross General Fund receipts for March 2024 totaled \$840.4 million, a decrease of \$2.2 million or 0.3 percent compared to the same period last year. Fiscal year-to-date, gross General Fund receipts totaled \$8,335.4 million. This is \$266.6 million more when compared to last year, for a year-to-date growth of 3.3 percent. The estimate for Fiscal Year 2024 is an increase of 0.6 percent.

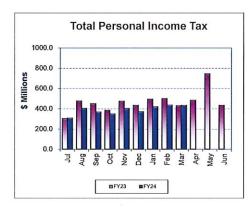
Summary

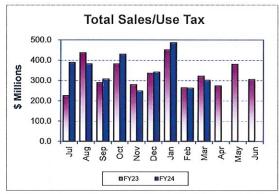
Fiscal year-to-date gross receipts on a cash basis are \$266.6 million more compared to the same period in Fiscal Year 2023, for a year-to-date growth of 3.3 percent. The current estimate is for an increase of 0.6 percent for the fiscal year.



Personal Income Tax

Personal income tax receipts totaled \$433.5 million during March 2024. This is \$4.4 million or 1.0 percent more than the receipts of March 2023. Withholding tax receipts increased \$28.4 million or 9.2 percent compared to last year. Estimated payments decreased \$9.6 million compared to last year. Final return payments decreased \$14.4 million. Fiscal year-to-date, personal income tax receipts totaled \$3,486.1 million, a decrease of 11.5 percent compared to the same period last year. The estimate for personal income tax for Fiscal Year 2024 is for a decrease of 9.9 percent.



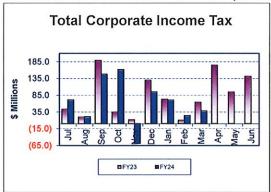


Sales/Use Tax

March sales/use tax receipts totaled \$300.1 million, which represents a decrease of \$21.4 million or 6.7 percent compared to March 2023. Fiscal year-to-date, sales/use tax receipts totaled \$3,143.3 million, an increase of \$163.4 million or 5.5 percent compared to the same period last year. The estimate for sales/use tax for Fiscal Year 2024 is for an increase of 6.2 percent over Fiscal Year 2023.

Corporate Income Tax

Corporate income tax receipts during March were \$38.1 million, which is \$25.8 million less than in March 2023. Fiscal year-to-date corporate income tax receipts totaled \$569.1 million, a decrease of \$4.7 million or 0.8 percent compared to the same period last year. The estimate for corporate income tax for Fiscal Year 2024 is for a decrease of 0.1 percent over Fiscal Year 2023.



Refunds

In March 2024, the Department of Revenue issued \$290.8 million in refunds on a cash basis. This compares to \$216.0 million issued March 2023. For the fiscal year-to-date, total refunds issued on a cash basis were \$854.5 million. This compares to \$575.3 million issued at this time last year.
