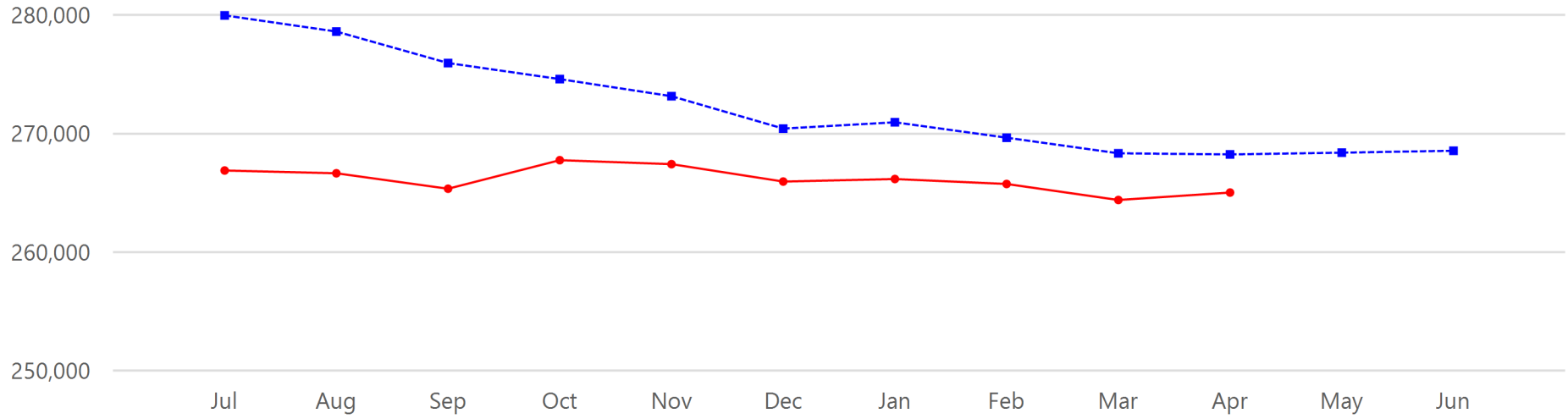

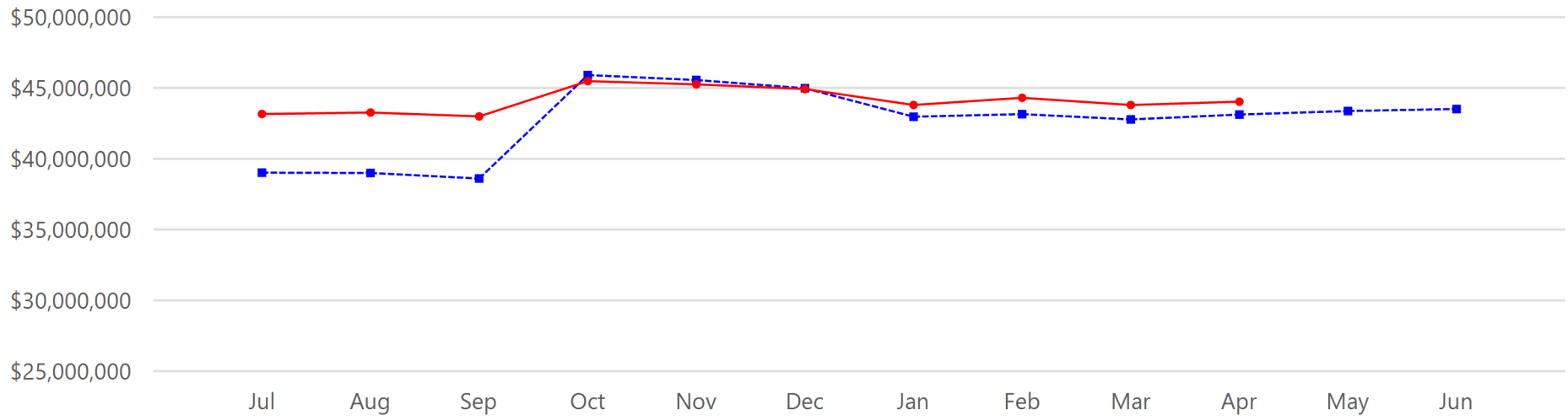
Total SNAP Recipients
