Auditor of State Rob Sand today released a report on the State University of Iowa (University of Iowa), Iowa City, Iowa for the year ended June 30, 2023. The University of Iowa previously released its annual financial report for the year ended June 30, 2023.

The University of Iowa is governed by the Board of Regents. For the year ended June 30, 2023, the full-time equivalent student enrollment was 28,518 with an average cost per student of \$21,727, compared to 28,224 students and an average cost per student of \$21,214 for the year ended June 30, 2022. The University Hospitals and Clinics provided a total of 582,129 patient days at an average daily cost per patient of \$3,909 for the year ended June 30, 2023, compared to 584,732 patient days at an average daily cost per patient of \$3,589 for the year ended June 30, 2022.


#### **AUDIT FINDINGS:**


Dear Members of the Board of Regents:

The State University of Iowa (University) is a part of the State of Iowa and, as such, has been included in our audit of the State's Annual Comprehensive Financial Report for the year ended June 30, 2023. We have also audited the financial statements of the University as of and for the year ended June 30, 2023 and have issued our report thereon dated December 18, 2023. We have also audited the University's compliance with the types of compliance requirements described in U.S. Office of Management and Budget (OMB) Compliance Supplement that have a direct and material effect on each of the University's major federal programs for the year ended June 30, 2023 and have issued our report thereon dated March 13, 2024.

In addition to these reports, we also prepare a separate report of recommendations pertaining to the University's internal control, compliance with statutory requirements and other matters when our audits disclose findings we believe should be brought to your attention. This report is to inform you our audits of the University of Iowa did not disclose any findings we believe were necessary to report for the year ended June 30, 2023.
