# DIRECTOR'S MESSAGE - FROM JUDY JEFFREY

### Pilot Projects Help Iowa Department of Education Map Future

The lowa Department of Education along with our partners in area education agencies (AEAs) and higher education are working as hard as ever to help students achieve. We have embarked on several initiatives that, at first, may seem unrelated. Take a closer look, and you will see a coordinated effort that focuses squarely on student success.

One initiative is the Iowa Core Curriculum. To understand this initiative, we must first look at content standards. In Iowa, we have statewide content standards in math, reading, and science. In 2007, the state legislature required school districts to adopt the <u>core content standards</u> from Iowa's federally approved standards and assessment system. While important, standards are just the start of curriculum reform. How it comes to life in the classroom is at the heart of the core curriculum initiative. The core curriculum, which currently districts may adopt voluntarily, provides teachers a tool to help ensure students meet the core standards. But it is much more than that. The core curriculum provides additional guidance on the concepts and skills that are necessary for all students to attain the standards.

This initiative began even before the legislature mandated the state's core content standards. In 2005, the department collaborated with representatives from various education stakeholder groups to construct the core curriculum for high school math, science, and literacy.

In 2007, the state legislature not only mandated the content standards, it also approved expanding the core curriculum to include kindergarten through 8<sup>th</sup> grade and the subject areas of social studies and 21<sup>st</sup> century learning skills, including civic, health, technology, and financial literacy, and employability skills. Social studies core content standards will also be provided in the expanded version.

Stakeholder work teams are now identifying the essential concepts and skill sets in these expanded areas and will offer a recommendation to the State Board of Education in April. Teams are also developing model teaching units in high school literacy, math, and science.

In developing a path for enhanced student achievement, the core content standards and core curriculum address what and how students will learn. The lowa Department of Education is going even deeper by taking on an initiative that addresses the depth of student learning. This initiative is called "authentic intellectual work." In simple terms, the department is helping schools engage students in higher-level thinking and in-depth understanding. Currently, there are teachers in nine high schools participating in authentic intellectual work training to improve instruction and we anticipate the number of participating schools will increase to 40 next year. The ultimate goal is to provide in-state trainers to schools throughout the state that wish to engage in this type of work.

Finally, lowa is one of 10 states working with the U.S. Department of Education on formative assessment. <u>Formative assessment</u> is a process of evaluating students during instruction so teachers can make instructional adjustments, if needed. It is assessment *for* learning, not assessment *of* learning. Through the pilot project, teachers are engaged in professional development aimed at improving assessment practices. There are currently four pilot high schools and more may be added next year.

By defining essential skills and concepts, helping schools develop ways to engage students in higher-level thinking, and providing teachers effective tools and frameworks, the department is laying out a road map to improved education in Iowa.

# **NEWS FROM THE DE**

#### 2007 Breaking Barriers Award Winners

Lt. Governor Patty Judge and members of the State Board of Education recently honored five Iowa school districts for improving gaps in student achievement. Charles City, Dubuque, Knoxville, Southeast Polk, and Waterloo community school districts each received a *Breaking Barriers to Learning and Teaching Award*, which was created by the State Board of Education to recognize successful efforts to eliminate achievement gaps by improving instruction, curriculum and programs, and professional development opportunities for school staff.

Districts earned the award if they made significant improvement among any subgroup of students in at least one grade level and subject, without allowing any other subgroup of students to decline significantly.

The State Board of Iowa and the Iowa Department of Education commend these districts for their efforts on providing support to struggling learners, while still addressing the learning needs of its high-achieving students.

# Open Enrollment 2007-2008 Transportation Assistance Rate Set at \$376

Eligibility for open enrollment transportation assistance to families that qualify is determined by the *resident* district. Transportation assistance is only available to families that open enroll between contiguous districts. The cost incurred by the resident district should be deducted from the per pupil tuition.

The resident district has the authority to determine how the assistance will be provided. The resident district may meet its statutory obligation in one of three ways:

- The resident district may provide transportation for the pupil(s) to a stop on the bus line of the receiving district.
- The resident district may allow the receiving district to enter the resident district to pick up the pupil(s) if the receiving district requests this arrangement.
- The resident district may provide a parent/guardian with reimbursement at \$376 for up to four children per family — one secondary and up to three elementary children.

### Effective Practices in Secondary Literacy workshop scheduled

The Effective Practices in Secondary Literacy: Instruction at the Core of Improved Student Learning in Middle and High School Literacy workshop will be held January 22 in West Des Moines and January 24 in Cedar Rapids. ### Second Chance Reading Academy Offered

This winter, the Iowa Department of Education (DE) will be offering a Second Chance Reading (aka Second Chance to Read) Academy. This session is being provided to assist districts that have had mid-year personnel turnover or have an urgent need to prepare a Second Chance Reading (SCR) teacher.

The DE will also offer a Second Chance Reading Training-of-Trainers sometime in June. To participate, individuals must have completed the initial SCR training and submit a completed application.

Second Chance Reading is a program that provides a specific course for struggling readers at the middle and high school levels. Second Chance Reading focuses on comprehension skills, vocabulary development, and fluency in both fiction and non-fiction textual materials.

### Student Records

Student records are the property of the school, not the student. When a student transfers to School B from School A, School A sends a COPY ONLY of the elements of the student's permanent file to School B. School A retains the original permanent file, and School B uses the copy sent to it as the building block on which School B builds its own permanent file for the student. # **Open Enrollment Appeal Decision**

At its December 13 meeting, the State Board issued new criteria for analyzing late-filed open enrollment requests that allege repeated acts of harassment. This was the first such appeal to the State Board following the enactment of the new anti-bullying/anti-harassment law and its definition of bullying and harassment. Accordingly, the new criteria are as follows:

1: The harassment must have occurred after March 1 or the student or parent is able to demonstrate that the extent of the harassment could not have been known until after March 1.

**2:** The harassment must be specific electronic, written, verbal, or physical acts or conduct toward the student which created an objectively hostile school environment that meets one or more of the following conditions:

- (1) Places the student in reasonable fear of harm to the student's person or property.
- (2) Has a substantially detrimental effect on the student's physical or mental health.
- (3) Has the effect of substantially interfering with a student's academic performance.

(4) Has the effect of substantially interfering with the student's ability to participate in or benefit from the services, activities, or privileges provided by a school.

**3:** The evidence must show that the harassment is likely to continue despite the efforts of school officials to resolve the situation.

4: Changing the student's school district will alleviate the situation.

A parent or guardian who files an application for open enrollment after the March 1 deadline and alleges repeated acts of harassment is entitled to a hearing before the resident school board to try to prove that the application should be granted. The new criteria should be used by local boards, school officials, and the State Board of Education.

#### School in a Disaster Area Reminder

When Governor Culver or President Bush, or both, declare certain areas to be "disaster areas," that declaration merely entitles the inhabitants to state and/or federal assistance. It does NOT mean that the district is excused from making up any lost school days!

# **Rules Proposed for Adoption**

The following chapters of the Iowa Department of Education (DE) administrative rules are in the early stages of formal rulemaking at the present time:

1. Chapter 17, open enrollment denials based on voluntary diversity (desegregation) plans

Only six districts presently have the ability to legally deny open enrollment requests based on desegregation plans. If any of those districts desires to maintain that ability it must submit a new "diversity" plan with the DE that has been adopted by its local board by March 1, 2008. These rules were published in the December 19 *Administrative Rules Bulletin* of the Iowa Legislature, available online at

Public hearing on these rules will be January 8 from 2:00 to 3:00 p.m. in the State Board Room at the Grimes State Office Building in Des Moines. These amendments are on track to be adopted by the State Board at its meeting on February 6.

### 2. Chapter 83, educator quality rules

This chapter of rules now includes the standards and criteria for area education agency (AEA) employees who meet the statutory teacher quality definition of "teacher," as well and the new standards and criteria for administrators under Iowa Code chapter 284A, Administrator Quality. These rules were published in the December 19 *Administrative Rules Bulletin* of the Iowa Legislature, available on-line at <a href="http://www.legis.state.ia.us/Rules/Current/Bulletin/IAB071219.htm">http://www.legis.state.ia.us/Rules/Current/Bulletin/IAB071219.htm</a> (scroll down to Iowa Department of Education rules) OR go to <a href="http://www.iowa.gov/educate/content/view/1130/104/">http://www.iowa.gov/educate/content/view/1130/104/</a> and click on Tab J. Public hearing on these rules will be January 8 from 1:00 to 2:00 p.m. in the State Board Room at the Grimes State Office Building in Des Moines. These amendments are on track to be adopted by the State Board at its meeting on February 6.

# 3. Chapter 36, academic eligibility for interscholastic sports

On December 13, the State Board voted to give public notice of its intent to amend the academic eligibility rule and to make other changes to the chapter of rules that govern interscholastic athletic competition. These rule changes are scheduled to be adopted by the State Board at its April 3 meeting. The primary change is to remove the requirement that the period of ineligibility be recognized only in a sport in which the student was a bona fide competitor. The second major amendment changes the period of ineligibility from 20 school days to 30 calendar days. A student who does not pass all credited coursework now is ineligible for *30 calendar days* in the next interscholastic athletic activity in which the student participates.

Other changes in the chapter 36 rules are as follows:

- 1. A new paragraph was added to remind member schools that all failing grades, even those remediated by the student for transcript purposes only, must be reported to a member school to which the student transfers.
- 2. The word "compete" is defined to include dressing in full uniform and participating in pregame warm-ups with their teammates. A student who is ineligible either because of the transfer rule or academic rule may practice with the team, but may not participate in pregame warm-ups and may not be in full uniform during competitions.
- Member schools are prohibited from allowing a student to compete in interscholastic competitions in the absence of reasonably reliable proof that the student is eligible to compete. (When a student transfers in, it is the obligation of the new school to withhold the student from competition until the school is certain that eligibility is not a question.)
