2.1.0 Statement of Objective

To provide coordination for the division and branches within the Department of Public Instruction dealing with the special needs population. Also to provide coordination between the DPI and agencies with the federal government structure and private organizations serving the special needs population.

The Coordinating Unit will be composed of representatives of all DPI divisions and branches dealing with handicapped and disadvantaged. They will meet on a weekly basis. Funds for the operation of the Coordinating Unit will come from the individual programs of the individuals constituting the Coordinating Unit.

- 2.1.1 The Coordinating Unit will meet with representative of appropriate federal agencies who are programming for children and adults with special needs. This might include, but not be limited to the following agencies: Commission for Civil Rights, HEW, OEO, VISTA.

2.6.0 Statement of Objective

During Fiscal Year 1974 an organized effort will be completed (primarily for NEW administrators and/or teachers and pupil personnel staff) to assist in the implementation, growth and development of educational programs and services for those children and adults requiring Special Kinds of Instruction. Attainment will be determined by gains and positive adjustments made by population served.

2.6.1 Description of Activity

Between August 15 and October 15, 1973 five workshops will be conducted for personnel assuming for the first time specific responsibilities in educational programs and services for children and adults requiring Special Kinds of Instruction. The workshops will serve a dual purpose of dissemination of information and assisting in the development of skills and techniques of those with direct contact with the Special Needs population. The workshops will be the responsibility of the Associate Superintendent for the Coordinating Unit who will involve personnel from the DPI and other state and local agencies as needed. The locations chosen for the workshops will be determined by a statewide survey showing the location of new personnel.

2.7 Statement of Objective

By June 30, 1974, the Curriculum and Instruction Branch of the DPI will structure guidelines for use by LEA to proliferate environmental education. A condition that will bear on the ultimate result is whether or not a federal environmental program will be enacted and funded by the target date. If federal funds are not forthcoming, the guidelines should nevertheless be structured. A constraint affecting this objective is whether or not the State appropriation will be adequate to fill a position vacancy within the Curriculum and Instruction Branch so as to have a professional staff member available to perform this task.

Attainment will be determined when the guidelines are in the hands of LEA's.

2.7.1 Description of Activity

A consultant, Curriculum and Instruction Branch, DPI, will, during all months of the fiscal year, develop guidelines for environmental reading programs to be used in LEA's. Before final publication, the proposed draft will be sent to several LEA's for their reactions and recommendations.

The desired outcome for this activity is to provide leadership in making students aware of their environment, to help them develop confidence in their ability to make judgments about what they like and don't like and to give them a sense of aspiration beyond the limits of the environment they know. This includes visual literacy, "to look understandingly at a painting, or a tree, or the facade of a building."

2.8 Statement of Objective

By June 30, 1974, a home economics consultant, Career Education Division of the DPI, will structure an innovative program in cooking designed for school children in grades 6 through 9. This cooking course will not be a part of the traditional home economics program, as excellent and beneficial as they are, but rather will be designed solely so that children with special needs may prepare minimal amounts of food when they are required to get their own breakfast or go without as well as when they are at home alone foraging for themselves.

Emphasis should be placed on preparing simple foods, particularly those foods these families would be apt to have on hand rather than those foods that are known to be of high nutritional content and value.

Attainment will be reached when a suggested innovative program has been designed using short, simple, meaningful words that are easy to read and understand together with simple, uncomplicated drawings and illustrations.

2.8.1 Description of Activity

A home economics consultant, Career Education Division, will during all months of the FY develop a manual described in Objective 1.2 to be used by LEA's. Before final publication this consultant will consult with OEC, CAP, Head Start, Extension Service USDA, and other local, federal, and state agencies to obtain their suggestions.

The desired outcome of this activity in its eventuality would be to teach hungry children to prepare easy-to-cook foods, such as toast, oatmeal, dry cereal, boiled potatoes, and the like, which would stave off the pangs of hunger. Such training should be more than 95% pure vocational training to learn by doing.

2.9 Statement of objective

By June 30, 1974, the Curriculum and Instruction Division of the DPI, will, in conjunction with the Title I Section of the DPI, structure an innovative program for elementary pupils in the lower grades that will focus on basic health and personal cleanliness. These DPI units will write courses of study with a manual in simple, short words with simple illustrations that can be furnished to schools having large concentrations of economically needy pupils.

This basic health and personal cleanliness course will include, among other things, to be performed at school during the normal school day:

- (a) Every pupil will be scheduled to either take a shower or a tub bath once a week. Towels will be furnished.
- (b) Pupils will be furnished with a small-sized tube of shampoo with which to shampoo their hair.
- (c) Pupils will be furnished with a toothbrush and small-sized tube of toothpaste and will be given instructions in their use.
- (d) Pupils will be furnished with shoe cleaning and shoe shining equipment to use in cleaning and polishing their shoes.
- (e) Every pupil will be furnished with a comb and hairbrush.
- (f) A small toilet kit will be furnished each pupil in which to put their personal toilet articles. All of this will become the personal property of the individual pupil, he will own it, and he will take it home at the end of the school year or whenever he leaves school, should this be midyear.
- (g) A hair drier will be purchased by the school district for girls to use.
- (h) A washing machine for clothing will be purchased and individual instruction will be given each pupil in its proper use. (Similar to what is currently being done for high school athletes.)
- (i) Every pupil will wash his clothing once a week in these washing machines.

- (j) An automatic clothes drier will be purchased by the school district and individual instruction will be given each pupil in its proper use. (Similar to what is currently being done for high school athletes.)
- (k) Irons and ironing boards will be purchased by the school district for use by both boys and girls. Individual vocational do-it-yourself instruction will be given each pupil.

Attainment will be determined when this course has been written and is ready to mail to Iowa's needy schools.

One constraint which seems easy to forecast will be the resistance of those persons who will flatly state that all of these basic health and personal cleanliness activities should be performed within the home. With this we concur because such would be the ideal situation. The argument for this type of education for life is that such is not now being done in some homes, both affluent and non-affluent.

2.9.1 Description of Activity

A consultant, Curriculum and Instruction Branch of the DPI, together with a consultant, Title I Section of the DPI, will, during all months of the fiscal year, develop courses, guidelines, and sets of instructions for use by LEA's having schools that have large numbers of economically needy pupils enrolled. Prior to final publication, the proposed draft will be sent to:

- (a) State Department of Social Services
- (b) State CEC office who will be asked to send the proposed draft to their local CAP agency workers who will be asked to discuss the program with their low-income families.
- (c) Several ADC Mothers' Chapters in the state.
- (d) Other local, state, and federal agencies who work with poor people.

These persons and agencies will be asked for their reactions and comments.

The desired outcome of this Activity is to provide leadership in designing innovative programs for Iowa's needy schools which will benefit the economically needy child with special needs. It is hoped that these children will be able to perform these simple tasks for themselves, even though they are young in age and thereby be able to keep themselves clean and neat in appearance.

2.10 Statement of Objective

By June 30, 1974, the Curriculum and Instruction Division of the DPI will structure another course in the Education for Life Series, and this will concern the inculcation of the sense of individual ownership and the desire to be responsible not only for one's property but the property of others as well.

Attainment will be determined when the course guidelines and instructions are in the hands of LEA's having large numbers of pupils with special needs.

A constraint that will hinder such a program will be the widespread belief that such a course is unnecessary and will have little value and that it should be performed in the home.

Each pupil could be furnished a small box with his name on it. In this box he can put treasured items, such as a rock, a button, a trinket, a whistle. He can go and look at them, hold them. No one else can have his property unless he says they can. He experiences absolute ownership. These items are his own.

2.10.1 Description of Activity

The consultant in charge of this training will, during all months of this fiscal year, develop this course to be used by LEA's concerned.

The desired outcome of this activity is to provide these pupils (with special needs) with an opportunity to experience the right of privacy. To learn that you respect others property so that others will respect yours. It would be hoped that these children would begin to develop an awareness of the significance and meaning of ownership. For some children this may be their first experience of truly having something of their own, even if it is a pretty stone.

A home economics consultant, Career Education Division, will during all months of the FY develop a manual described in Objective 1.2 to be used by LEA's. Before final publication this consultant will consult with OEC, CAP, Head Start, Extension Service USDA, and other local, federal, and state agencies to obtain their suggestions.

The cost of this Activity is estimated to be:

Federal: 3 months consultant's time	\$4065

The desired outcome of this activity in its eventuality would be to teach hungry children to prepare easy-to-cook foods, such as toast, oatmeal, dry cereal, boiled potatoes, and the like, which would stave off the pangs of hunger. Such training should be more than 95% pure vocational training to learn by doing.

2.9 Statement of objective

By June 30, 1974, the Curriculum and Instruction Division of the DPI, will, in conjunction with the Title I Section of the DPI, structure an innovative program for elementary pupils in the lower grades that will focus on basic health and personal cleanliness. These DPI units will write courses of study with a manual in simple, short words with simple illustrations that can be furnished to schools having large concentrations of economically needy pupils.

This basic health and personal cleanliness course will include, among other things, to be performed at school during the normal school day:

- (a) Every pupil will be scheduled to either take a shower or a tub bath once a week. Towels will be furnished.
- (b) Pupils will be furnished with a small-sized tube of shampoo with which to shampoo their hair.
- (c) Pupils will be furnished with a toothbrush and small-sized tube of toothpaste and will be given instructions in their use.
- (d) Pupils will be furnished with shoe cleaning and shoe shining equipment to use in cleaning and polishing their shoes.
- (e) Every pupil will be furnished with a comb and hairbrush.
- (f) A small toilet kit will be furnished each pupil in which to put their personal toilet articles. All of this will become the personal property of the individual pupil, he will own it, and he will take it home at the end of the school year or whenever he leaves school, should this be midyear.
- (g) A hair drier will be purchased by the school district for girls to use.
- (h) A washing machine for clothing will be purchased and individual instruction will be given each pupil in its proper use. (Similar to what is currently being done for high school athletes.)
- (i) Every pupil will wash his clothing once a week in these washing machines.

- (j) An automatic clothes drier will be purchased by the school district and individual instruction will be given each pupil in its proper use. (Similar to what is currently being done for high school athletes.)
- (k) Irons and ironing boards will be purchased by the school district for use by both boys and girls. Individual vocational do-it-yourself instruction will be given each pupil.

Attainment will be determined when this course has been written and is ready to mail to Iowa's needy schools.

One constraint which seems easy to forecast will be the resistance of those persons who will flatly state that all of these basic health and personal cleanliness activities should be performed within the home. With this we concur because such would be the ideal situation. The argument for this type of education for life is that such is not now being done in some homes, both affluent and non-affluent.

2.9.1 Description of Activity

A consultant, Curriculum and Instruction Branch of the DPI, together with a consultant, Title I Section of the DPI, will, during all months of the fiscal year, develop courses, guidelines, and sets of instructions for use by LEA's having schools that have large numbers of economically needy pupils enrolled. Prior to final publication, the proposed draft will be sent to:

- (a) State Department of Social Services
- (b) State CEC office who will be asked to send the proposed draft to their local CAP agency workers who will be asked to discuss the program with their low-income families.
- (c) Several ADC Mothers' Chapters in the state.
- (d) Other local, state, and federal agencies who work with poor people.

These persons and agencies will be asked for their reactions and comments.

The desired outcome of this Activity is to provide leadership in designing innovative programs for Iowa's needy schools which will benefit the economically needy child with special needs. It is hoped that these children will be able to perform these simple tasks for themselves, even though they are young in age and thereby be able to keep themselves clean and neat in appearance.

2.10 Statement of Objective

By June 30, 1974, the Curriculum and Instruction Division of the DPI will structure another course in the Education for Life Series, and this will concern the inculcation of the sense of individual ownership and the desire to be responsible not only for one's property but the property of others as well.

Attainment will be determined when the course guidelines and instructions are in the hands of LEA's having large numbers of pupils with special needs.

A constraint that will hinder such a program will be the widespread belief that such a course is unnecessary and will have little value and that it should be performed in the home.

Each pupil could be furnished a small box with his name on it. In this box he can put treasured items, such as a rock, a button, a trinket, a whistle. He can go and look at them, hold them. No one else can have his property unless he says they can. He experiences absolute ownership. These items are his own.

2.10.1 Description of Activity

The consultant in charge of this training will, during all months of this fiscal year, develop this course to be used by LEA's concerned.

The cost of this Activity is estimated at:

State: 3 months consultant's time	\$4065
Clerical 1 mo.	524

The desired outcome of this activity is to provide these pupils (with special needs) with an opportunity to experience the right of privacy. To learn that you respect others property so that others will respect yours. It would be hoped that these children would begin to develop an awareness of the significance and meaning of ownership. For some children this may be their first experience of truly having something of their own, even if it is a pretty stone.
