#### Incident Type Key

- I - Involuntary** A person of any age who is missing under circumstances indicating that the disappearance was not voluntary, i.e., abduction or kidnapping.
- E - Endangered** A person of any age who is missing under circumstances indicating that his/her physical safety is in danger.
- D - Disabled** A person of any age who is missing and under proven physical/mental disability or is senile, thereby subjecting himself/herself or others to personal and immediate danger.
- V - Catastrophe** A person of any age who is missing after a catastrophe, (i.e., victims of disasters, such as tornadoes, etc.)
- K - Familial Kidnap** A minor who is missing and has been declared unemancipated as defined by the laws of his/her state of residence and who has been abducted by non-custodial parent or relative.
- LW - Lost/Wandered Away** A minor who is lost or has wandered away. This category does not include those persons taken by force or runawa**Juvenile** A person who is missing and declared unemancipated as defined by the laws of his/her state of residence and does not meet any of the entry criteria for Disability, Endangered, Involuntary, Parental Abduction, or Lost or Wandered Away.

**The Need** - There's no question that today's law enforcement officers are better trained than ever before. Specialized courses are available that cover practically every situation an officer or investigator is likely to encounter, from arson and burglary, to homicide and robbery. As important as these situations are, however, few assignments demand more from law enforcement personnel, both professionally and emotionally, than the report of a missing or abducted child. What other incident brings about the same outpouring of community concern - volunteer search teams, poster distribution, even candlelight vigils? What other incident places such intense pressure and unrelenting media scrutiny on a law enforcement agency to solve the disappearance? And, what other incident takes such an emotional toll on the assigned officers when a prompt solution isn't reached? Yet, even with the recognition that incidents of missing and abducted children can be as complex and demanding as any law enforcement challenge, few training programs are available to guide officers and investigators when these critical cases occur.

**The Response** - Recognizing this need, The National Center for Missing and Exploited Children (NCMEC) has developed a specialized training program aimed at the swift and successful investigation of reports involving missing and abducted children. **Missing and Abducted Children: A Survival Program for First Responders and Initial Investigators**, is designed to provide critical information to those officers and investigators who will respond to a missing child report and whose knowledge, skill, and ability may make the difference between prompt recovery and a protracted investigation. In addition to reactive investigative techniques, attendees will also gain valuable proactive knowledge to better prepare them for encounters with potential child predators.

Presented in a fast-paced format, this program is accentuated with high impact videos, case histories, investigative scenarios, and group participation exercises.

**The Organization** - Established in 1984 and funded by the US Office of Juvenile Justice and Delinquency Prevention, NCMEC serves as the nation's clearinghouse for information on missing and exploited children. Since its inception, NCMEC approved presenters have provided training for more than 150,000 law enforcement, criminal justice, and child protection professionals in the United States and abroad.

**The Presenter** – This program will be presented by Stephen Steidel, NCMEC's Associate Director of Training. Prior to his affiliation with NCMEC, Mr. Steidel served with the Suffolk County (NY) Police Department, where he held a number of investigative and supervisory positions including commander of the Missing Persons Bureau. In addition to his duties as a NCMEC trainer, Mr. Steidel also assists local law enforcement agencies in areas such as the design of effective policies and procedures, the development of regional response plans, and other efforts aimed at enhancing an agency's overall response to cases of missing or abducted children.

**The Cost to Agencies** – No cost for training – agencies will need to provide transportation, meals and lodging.
