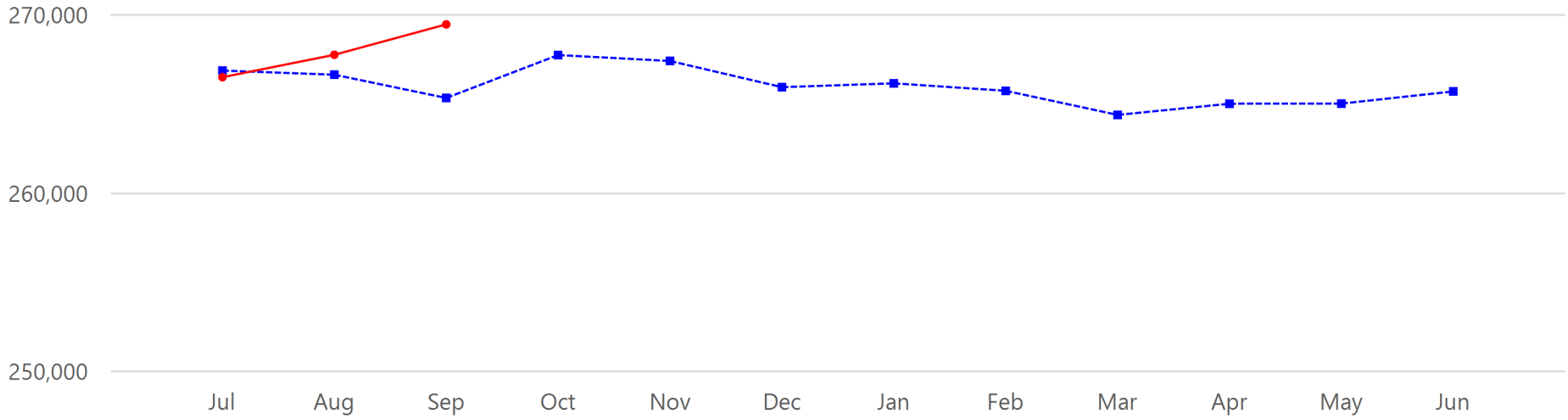

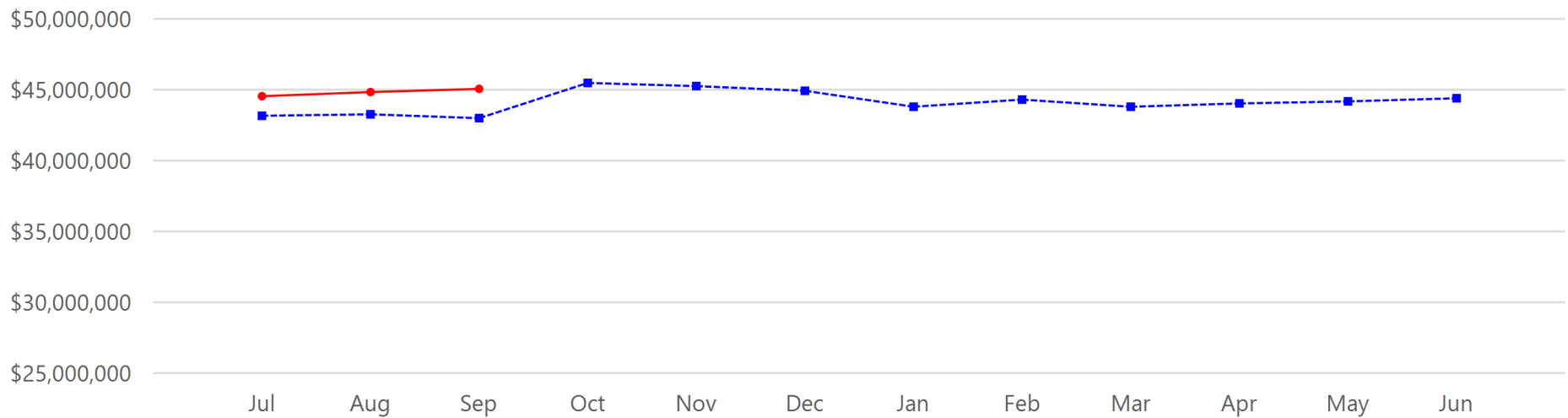
## Total SNAP Recipients

It is calculated by dividing the number of SNAP Recipients in an area (County/SA/State) by the number of persons in that area at or below 160% of the Federal Poverty Level (as counted in the 2020 American Community Survey).
