New Director Meet-Ups



Beginning in January

At the State Library, the District Consultants and the Library Resource Techs (LRTs) for each District are often the first point of contact for newly hired library directors. District Consultants make initial visits to all libraries that welcome new directors, providing a State Library orientation; LRTs are in touch to assist with questions surrounding SILO, websites, Bridges, and much more.

Come **January 14, 2025 (1:00-2:00PM)** the District Consultants are teaming up to build on our initial orientation visits by inviting all new directors to join us in ZOOM for what we're calling **"New Director Meet-Ups."**

The idea is to extend our early conversations with new people by meeting online and offering the chance to talk about library management issues in more detail. Plus, we also see this as a great way to introduce new directors to each other, inside and outside of your own District. It's called networking, ya'all 😊

January will be our first such gathering, we're aiming for 3 times a year--winter, spring, and fall. And what do we consider "new?" We're thinking people who have been on the job for 1 year or less, although that question is really best answered by you. If you're a new library director for one month, for one year, or a bit longer, this gathering will help you build connections with colleagues--that's the goal !

E-Rate Form470 Filing Window Open



E-Rate is a federal program that helps make Internet service more affordable for public libraries and schools. In order to qualify for E-rate funds for Internet and WiFi access, libraries must (1) have an Internet Use Policy (2) provide a Technology Protection Measure on library owned computers to comply with the Children's Internet Protection Act (CIPA) and (3) hold a public notice or

meeting to address the proposed technology protection measure and Internet safety policy.

About 90 Iowa public libraries take advantage of E-Rate funding, saving anywhere from 60% to 80% off their Internet bill. Filing is done online in stages as various "windows" open. The first form in the filing sequence is **Form 470**. This form opens the required competitive bidding process, allowing service providers to review the posted form and submit bids for the requested Internet speed and equipment.

The filing window for Form 470 is now open and is expected to close sometime in February, so we encourage libraries interested in pursuing E-Rate to begin soon.

New In Funding Year 2025: Internet Hotspots & Service Qualify

For the first time starting beginning in FY 2025, WiFi hotspots and mobile wireless Internet service that can be used off-premises will be eligible for E-Rate funding. In addition, the budget for WiFi hotspots will be on a fixed three-year cycle. There are funding caps in place for the maximum pre-discount costs permitted to be reimbursed for hotspots and Internet service plans purchased through E-Rate. The pre-discount funding caps are:

- \$90 per hotspot device
- \$15 per month for recurring wireless internet service

Off-Premises Wi-Fi Hotspots Overview

Following **Form 470**, two additional forms must be filed at specific intervals: **Form 471** is the second one: it's the actual E-rate application to request discounts on eligible services and equipment for the upcoming funding year. Then comes **Form 486** which notifies USAC (Universal Service Administrative Company) that services have started for the library and certifies that the library is complying with CIPA.

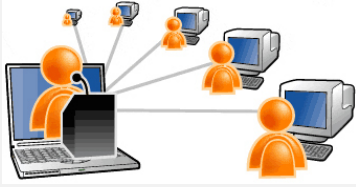
