Transitioning to the WorkDay Learning platform



takes the top spot in our 2024 highlight reel. This was a very big endeavor—and an unexpected one—when we learned that this switch was to be required for all the agencies within the Dept of Administrative Services (DAS) That's the State Library's new Department home, so the move was on! Continuing Education Consultant Samantha Bouwers took the reins and won an MVP award from DAS for her work on this project. Thank you, Sam!

#### Monday Morning Eye-Opener January 6, 2025

In June, we added an important new resource to our "Toolkit" page: *The Public Library Compensation Toolkit*. This *Toolkit* provides library boards, directors, and staff guidance needed to address these inequities and request fair and competitive compensation. Two webinars in August stepped library directors and boards through this new *Toolkit*, find those webinars on our <u>Continuing Education YouTube Channel</u>.

in 2024, we launched a mini-series called "*Lunch & Learn with State Library Staff.*" These 30-minute ZOOM sessions over the lunch hour focused on State Library people, programs, and services. We covered a lot of ground: from the role of District Staff, to Specialized Consulting Services, to the State Data Center. We also talked about Bridges, SILO-ILL, WhoFi, and more. Each one was recorded, find them on our <u>Continuing Education YouTube Channel</u>.

**The People's Law Library** continued to expand its offerings: in 2024 came **Voting Law**, **Insurance Law**, and **Workplace Law**. This is an impressive resource to share with your patrons, we hope you'll link to **The People's Law Library** from your own website and encourage your users to go there—actually, this would make for a nice informational program @ your library in the new year!

### **Even More Highlights From 2024**

- District consultants delivered a wide range of library-focused presentations, both in person and online. They provided CE for countywide meetings, for staff development days, for individual board meetings, and orientations for new library directors. District Consultants made 423 in-person visits to libraries and provided 129 virtual training sessions.
- Trauma Informed Libraries: Reflective Practice Sessions launched and Staff & Administrator Endorsement Modules were added to WorkDay Learning
- Successful launch and completion of the Supercharged Storytime Cohort
- Successful completion in September of our Federal 5-Year Site Visit
- WhoFi's Question Sets has been live for one year and libraries that used this service were able to have their data imported into their Public Library Annual Survey.

We experienced key staffing changes as well this past year, with the retirements of Mandy Easter and Scott Dermont, while Brenda Hall took the helm as Interim State Librarian in October. Here's a toast to 2024—a busy and eventful year at the State Library and all across the Iowa library community. Looking forward to a successful 2025!

### **Continuing Education Highlights**

2024 was quite a year for the State Library's Continuing Education Program, most notably in successfully moving from IALearns to WorkDay Learning. Added thanks to Sam Bouwers for providing this CE summary about 2024:



"The CE Team reflected on all the fun stuff from last year, including:

- A combination of 93 webinars and in-person workshops attended by 4,200 people
- Over 800 people attended the in-person events. These included Pop YS Con, Director Roundtables, the Learning Circuit, and the Space Planning workshops. One attendee called the Space Planning Workshop the best she'd ever been to Contemport
- The amount of training hours offered by the State Library in 2024 was longer than the length of every Emily Henry audiobook combined!
- We approved over 870 requests for external CE credits—meaning credits from other education providers—and lowa library staff logged over 500 training hours in WebJunction.

Sam adds these stats about WorkDay Learning: "Our 'Partridge in a Pear Tree,' so to speak, was the unexpected transition from IA Learns to Workday Learning. This project included cleaning up more than 4,000 user accounts, recreating about 200 webinar archive courses, and manually tracking about 2,000 endorsements.
