OWA BOOKING CONFERENCE Presenters and artists will have the opportunity to learn more about presenting the performing arts at the 1988 Iowa Booking Conference. Sharing Excellence is the theme for our 2nd annual conference and from the preliminary agenda, it will be exciting and beneficial. The dates are November 11-12 and will be is being held at the Music Building on the Iowa State University campus in Ames. A big THANK YOU goes to Carl Bleyle (Musica Antiqua) for assisting us with the arrangements at ISU. The workshops and artist showcases will be held in the Music Building so there will be no need to move from one location to another as we did in Des Moines last year. The ISU Memorial Union is nearby for ample parking and dining facilities.

The keynote speaker will be Joan Mondale, wife of former Vice-President Walter Mondale. A long-time friend and supporter of the arts, Ms. Mondale will speak on the future of the performing arts.

Other workshops and sessions to be held include the following:

Using an Agent/Management Company, Iowa Arts Council Grant Writing for Presenters, Iowa Arts Council Artist Opportunities, Innovative and Inter-disciplinary Programming, Block-Booking in Your Region, Developing the Performing Arts, Creative Marketing for Artists, Arts Midwest Grant Writing, Arts Midwest Artist Opportunities, Arts Education, The Decline of Leisure Time,...others to be announced.

The Performing Artist Showcase has been expanded to include two performances at this year's Conference. Due to the added

numbers of artists on the roster for the 89-90 touring season, we will have a Showcase each day. The artists who will be performing are those available for the touring season which begins on July 1, 1989 and continues through June 30, 1990. Those artists were selected and approved in July. Presenters may submit applications for the 89-90 touring season beginning December 1, 1988.

I hope everyone will plan on attending this Conference. Whether you book one artist a year or 10, this Conference will assist you in selecting the right artist and teach you new information about presenting the performing arts in your community. For the artists, it provides a great marketing tool and enables them to promote themselves to lowa presenters.

The 89-90 Arts to Go brochure containing more information about artists and groups will be available in November. The first issues will be available at the Booking conference in Ames and mailed to Iowa Arts Council constituents later that month. Be sure to attend the Conference on November 11-12 for the opportunity to see many of the artists perform and to arrange bookings. By making arrangements in advance, you have a better opportunity for Iowa Arts Council fee support.

If you have read this far, you have by now realized that our Grants-in-Aid program has a new name. Now the Grassroots Partnership Incentive Program, this new image will assist us in

effectively marketing the program with the emphasis on "partnership". The lowa Arts Council had developed working relationships with many individuals and organizations throughout the 21 year history of the agency and we now wish to "sell" a new image reflecting on the successes of those partnerships. As we advance through the upcoming year, I am sure you will begin to see the effects of our new imagebuilding ideas and how they will directly benefit our constituents.

GRASSROOTS PROGRAM GUIDELINES

The Grassroots Partnership Incentive Program brochure is currently being published, and as always, will contain information about the following categories: Project Grants, Salary Support Grants, Visual Arts Touring Exhibition Grants, Mini-Grants, Community Arts Challenge Grants and Operational Support Grants for Major Institutions. Brochures will be mailed in early October to those constituents on our mailing list. Additional copies may be requested from the lowa Arts Council office.

Guideline changes have also occurred in the program for Fiscal Year 1990 (July 1, 1989 through June 30, 1990) so it will be important to read the brochure carefully and thoroughly. The major change involves individual artist grants. The Grassroots Partnership Incentive Program will not have a category for individuals, but will be designed only for nonprofit, tax-exempt organizations.

Individual artists seeking grant support from the lowa Arts Council will be interested in programs being developed and announced this fall. Bruce Williams, Director of Visual Arts and Creative Artist Programs is currently working on the development of these services.

To receive information about these new offerings, contact the lowa Arts Council office and request to be added to our mailing list.

Under the Mini-Grant category for Fiscal Year 90, constituents will be required to complete the Project Grant application form in order to apply for a Mini-Grant. In the past, we have allowed submission of a letter containing specific information about the project for which funds are requested. Generally we have found this method to be difficult for review processes. Without the staff time to call each applicant to fill-in information, the letters tend to be inconsistent. By completing the Project Grant application form, the Iowa Arts Council will be better able to fairly review and evaluate each emergency project.

Another change which should assist in streamlining review of grant applications involves the addition of another advisory panel to our Grassroots Partnership Incentive program. The Community Arts Advisory Panel will only review the Community Arts Challenge Grants and Salary Support Grants from local arts agencies. Applications for specific discipline (i.e., music, visual arts, etc.)projects from local arts agencies will be assigned to discipline panels. We have also added a Multi-Discipline Advisory Panel to review those applications which request funds for a project which involves more than one discipline.

The membership of our grant advisory panels will also change for the upcoming year. Due to budget restraints, we have decreased the size of our panels to four members at-large with a voting member from the lowa Arts Council board and a Chair-person (also an Iowa Arts

Council board member). The four members at-large will be geographically selected from the four quadrants of the State of lowa and we will also attempt to have a gender balance among those four panelists. Panelists were selected during the month of August and asked to serve in this important capacity. The Iowa Arts Council is always open to nominations from the field for panelists. If you would be interested in serving on a grant advisory panel, or know someone who would, we encourage you to submit names to us.

As many of you know, the lowa Arts Council has been working through a process to change our service contract. It has been a slow procedure which has involved the Attorney General's office and a great deal of staff time. We have, in the past, had a different contract form for each Iowa Arts Council program. After the long process of revision, we now have one contract which will serve every program. With this new contract, we will also initiate a new payment procedure. Regardless of the date of your project, the contract will be paid within 45 days after it is returned from the constituent and signed by the Iowa Arts Council Executive Director. This will eliminate the old system of using a Cash Request Card. If you have questions about this new processing system, please contact our office.

Preregistration is not required; however, we appreciate knowing in advance an approximate number of participants.

As required by our Auditor's Office, I will be conducting several site visits during this Fiscal Year to organizations and projects supported by our **Grassroots Partnership** Incentive program. These site visits assist us in getting better acquainted with our constituents (in addition to being FUN!) and assure the National Endowment for the Arts that dollars are being spent

in accordance with their guidelines. A few of these site visits will involve an audit of records, therefore it is important for constituents receiving grant funds to keep records in good order. It is crucial for you to be able to track how the grant funds were spent with receipts and proper documentation.

Site visits recently completed included visits to the Orange City Arts Council (Salary Support Grant) and the Sioux County Arts Council (several Project Grants). I appreciated the hospitality received while in Northwest Iowa and look forward to visiting more lowa communities this year.

The National Endowment for the Arts offers a variety of grants which might benefit your organization. I have included here a listing of the various divisions offering grants to organizations and the deadline dates.
