Targeted Small Business Update Procurement and Compliance Overview

Targeted Small Business (TSB) compliance is authorized by Iowa Code Chapter 19B.7. Iowa Code Chapters 73.16-73.19 requires the establishment of TSB procurement provisions through the Departments of Management, Inspections and Appeals and Economic Development.

This report will provide an overview of the State of Iowa's Targeted Small Business Program and efforts to assure equal opportunity through targeted small business procurement during FY 2007.

Targeted Small Business Update Department of Inspections and Appeals

The Departments of Administrative Services, Economic Development and Inspections and Appeals are jointly responsible for the State's Targeted Small Business Program. Serving as a TSB Task Force, they market the program, offer a financial assistance program, provide procurement opportunities and educate their partners in purchasing and certification. Partners include all state agencies, TSBs, potential TSBs, private businesses, local government, school districts and federal agencies.

To increase the interest and participation for loans, certification and purchasing, the Task Force is expanding its efforts to reach those populations not previously involved in the TSB program. This will be done through marketing the program to minority organizations and populations, and training TSBs in how to market their business to purchasers and prepare bid documents. In the semi-annual seminars sponsored by the Task Force since 2001, purchasers from state government, as well as the Task Force, are speakers. TSBs are invited to attend to learn how to do business with the State of Iowa.

Over the past few years, the TSB Program has seen a decline in the number of active TSBs. The passage of HF 890 is intended to reverse this trend. The following reflect statistics for FY 07 compared to FY 06.

- At the end of FY 07, there were 458 active TSBs. This was a 27% decrease in the number of active TSBs over the number of active TSBs at the end of FY 06 (582). This is a trend that we have been seeing for several years.
- There were 122 new and renewal applications approved for full Certification or Conditional Certification during FY 07, compared to 319 during FY 06 – a 62% decrease. Although re-certification is done every two years and may account for some of this decrease, we have also seen TSBs not re-certifying, being out of business, or not responding to renewal notices.
- There were no TSBs de-certified during FY 07 or FY 06.
- During FY 07, presentations were made at five seminars/conferences (with attendance exceeding 300 participants). In addition, a radio broadcast was conducted in Des Moines in collaboration with the Department of Human Rights, Latino Affairs Division.

With the passage of HF 890 during the 2007 legislative session, The Department of Inspections and Appeals (DIA) was authorized to hire additional staff to enhance certification and marketing efforts. Since July 2007, we have enhanced our staffing level, collaborated with other state agencies to enhance the TSB Program, presented at multiple seminars/conferences, and attended diversity events, all with the purpose of increasing the number of TSBs in Iowa. The results of these and future efforts will be reflected in our FY 2008 report.

TSB Contracts

DAS Procurement Services creates contracts with TSBs and informs agencies about these contracts and the TSB Program at quarterly statewide purchasing meetings. A list of all TSB contracts is given to meeting attendees and TSBs are invited to give product presentations. DAS Procurement Services has created 68 TSB contracts, 31 of which have been added since May 1, 2007.

DAS Procurement Services Responds to TSB Questions

DAS received many phone calls and e-mails from targeted small businesses asking about how to do business with the State of Iowa. We try to respond to each business and provide useful information.

One example is a contact Nola Penland, DAS Procurement Services Purchasing Agent, had with Oswaldo Barcelon, owner of Sonora Tortilla, a new TSB. Oswaldo had many questions regarding the state’s contracting and solicitation process. Nola explained the processes and created a TSB contract for his business. Nola then visited his location to personally see his production process.

Targeted Small Business Financial Assistance Program Iowa Department of Economic Development

The purpose of the Targeted Small Business Financial Assistance Program (TSBFAP) is to provide financial aid to women, minorities and persons with disabilities who are majority owners of businesses certified by the Iowa Department of Inspection and Appeals.

The program did not receive any funding in FY 07. The balance forward from FY 06 was zero.

House File 890 provided the TSB Program with \$4 million dollars for FY 2008. Of this amount, \$ 2.5 million is designated for financial assistance. The remaining \$1.5 million is for one full-time employee (FTE) to manage the certification process at DIA and one FTE for marketing and compliance at IDED and for contracting with technical assistance service providers.
