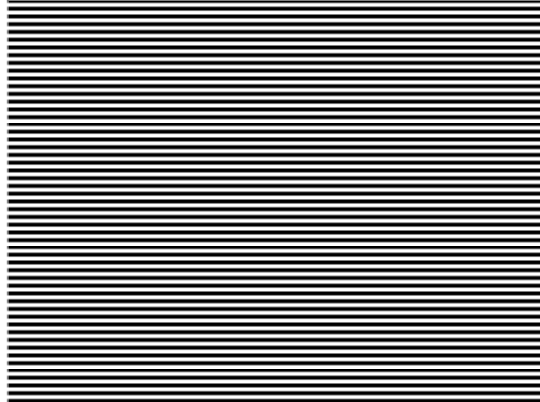

Auditor of State David A. Vaudt today released a report on the Iowa School for the Deaf, Council Bluffs, Iowa for the year ended June 30, 2007.

The School is governed by the Board of Regents, State of Iowa and provides an education commensurate with the needs of students who are Iowa residents and less than twenty-one years of age with hearing loss which is too severe to acquire an education in the public schools. The School also provides services for residents of the State of Nebraska upon such terms as may be fixed by the Board of Regents. For the year ended June 30, 2007, the average enrollment was 109 students with an average cost per student of \$99,382, compared to an average enrollment of 104 students and an average cost per student of \$99,656 for the prior year. During the year ended June 30, 2007, the School provided outreach services to 71 off campus students compared to 80 off campus students during the year ended June 30, 2006.

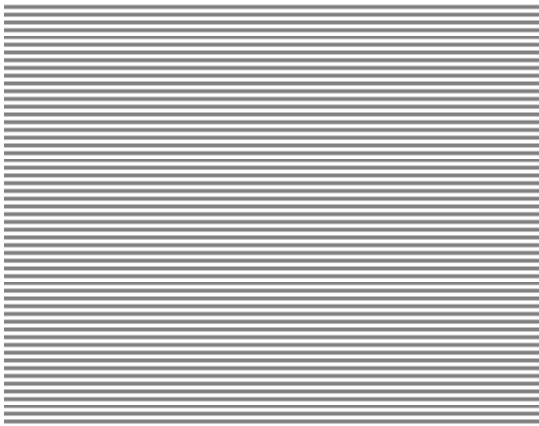

To the Members of the Board of Regents,
State of Iowa:

The Iowa School for the Deaf is a part of the State of Iowa and, as such, has been included in our audits of the State's Comprehensive Annual Financial Report (CAFR) and the State's Single Audit Report for the year ended June 30, 2007. In addition to these reports, we also prepare a separate report of recommendations pertaining to each School's internal control, compliance with statutory requirements and other matters when our audits disclose findings we believe should be brought to your attention.

** Included in the average cost per student are expenditures for outreach services for which the costs have not been identified separately. During the year ended June 30, 2007, the School provided outreach services to 71 off campus students compared to 80, 86, 87 and 99 off campus students, respectively, in each of the preceding four years ended June 30, 2006.
