SENATE PASSES THE OPTICAL SCAN VOTING SYSTEM BILL – SF 2347

Optical Scan Requirement

The Senate passed SF 2347 (Optical Scan Voting System Bill) requiring counties to purchase optical scan voting systems for elections held on or after November 4, 2008. The Bill creates the Optical Scan Voting System Fund and appropriates \$4.9 million from the Rebuild Iowa Infrastructure Fund (RIIF) to the Fund. In addition, the Bill transfers \$2.0 million from the Voting Machine Reimbursement Fund to the Optical Scan Voting System Fund.

Deappropriations

The Bill also deappropriates a total of \$4.6 million from FY 2008 RIIF appropriations, including \$3.6 million for the purchase of a new State office building and \$1.0 million for a feasibility study for improvements to the Workforce Development Building.

AGRICULTURE AND NATURAL RESOURCES APPROPRIATIONS SUBCOMMITTEE PASSES FY 2008 APPROPRIATIONS BILL – HSB 784

Appropriations Bill

The Agriculture and Natural Resources Appropriations Subcommittee passed HSB 784 (FY 2009 Agriculture and Natural Resources Appropriations Bill) on March 12. The Bill appropriates a total of \$43.4 million from the General Fund and 1,632.7 positions, a decrease of \$235,000 and no change in positions compared to estimated FY 2008. The Bill also appropriates \$82.7 million in other funds. This is no change compared to estimated FY 2008. Significant changes are outlined below.

REAP

An Environment First Fund increase of \$500,000 to the Resource Enhancement and Protection (REAP) Fund.

District Commissioners	A General Fund increase of \$150,000 to the Soil and Water Conservation District Commissioners for expenditure reimbursement.		
Natural Resources	A General Fund decrease of \$250,000 to the Department of Natural Resources operations for a general reduction.		
Administration	Increases the percentage from 5.0% to 7.0% for the amount of program funding DALS can use for administrative expenditures for the Conservation Reserve and Enhancement Program, Watershed Protection Fund, Farm Demonstration Management Program, Conservation Reserve Program, and Agriculture Drainage Wells Program. The fiscal impact is an increase of \$158,000 for administrative expenses.
