#### **VETERANS COUNTY GRANT PROGRAM AND WAR MEMORIAL TRANSFER**

**Transfer:** The Department of Management notified the Co-Chairpersons and Ranking Members of the Full Appropriations Committee and the Co-Chairpersons and Ranking Members of the Health and Human Services Appropriations Subcommittees on October 16 of the intent to transfer \$100,000 from the Veterans County Grant Program to the Administration line-item of the Department of Veterans Affairs. The \$100,000 is to be used for the State portion of the planned memorial plaza to honor veterans in Dubuque, Iowa. The original \$100,000 for the State portion of the plaza was to be from the proceeds of bond sales authorized in SF 2342 (FY 2009 Rebuild Iowa Infrastructure Fund Act). The State Treasurer announced on October 10, 2008, that all of the bonding authorized in SF 2342 would be delayed until the nationwide credit issues stabilize.

#### **IOWA RANKS FIRST IN COLLEGE STUDENT DEBT - 2007**

**Project on Student Debt:** The Project on Student Debt recently issued the third annual report on college student debt trends. College student debt levels continue to rise overall. Nationwide, the average debt for students graduating with loans rose from \$18,976 to \$20,098, a 6.0% increase. For comparison, the earnings for 18- to 24-year-olds with bachelor's degrees rose 3.0% or half the growth rate for student debt. The increase in student debt was roughly the same for public and private colleges. For the class of 2007, the average debt at public colleges was \$18,482 and \$23,065 at private colleges. (Due to data limitations, the average debt estimates are probably somewhat low.)

**lowa's Rank:** lowa ranks first in the nation for college student debt with a \$26,208 average, up from last year's second place ranking of \$24,769. Utah continues in last place with an average debt of \$13,266, up from \$12,296 in 2006. The percentage of lowa students graduating with debt declined from 74.0% to 73.0%, and the national ranking for the percentage of students graduating with debt declined from second to fourth place. Hawaii continues to rank last for the percentage of students graduating with debt. In 2007, 34.0% of Hawaii's new college graduates had student debt, a 2.0% increase from 2006.
