Nearly 40,000 Iowans Apply for Assistance

Following this spring's tornadoes, flooding and severe storms, nearly 40,000 Iowans have registered for Individual Assistance program funding.

As of Nov. 4, more than \$790 million in disaster assistance has been approved for homeowners, renters, businesses, and government and non-profit entities in the following categories:

\$117.5 million for Housing Assistance, which may be used for temporary disaster housing and repair of owner-occupied disaster-damaged homes.

HSGP Grant Allocations Announced

Funds for the FFY 2008 Homeland Security Grant Program have been awarded to Iowa's local and state entities. Iowa received \$6.1 million for the 2008 Homeland Security Grant Program (HSGP), down from \$7 million that was received in the 2007 program.

Meetings between HSEMD and local and state recipients will be conducted during November and December to provide information and help in the preparation of agreement articles, scopes of work, and detailed budget.

Specific information about that process will be distributed to grant recipients by mid-November.

Advanced Law Enforcement Rapid Response Training (ALERT) Active Shooter Training "Train the Trainer"

The mission of ALERT is to teach law enforcement officers, specifically the true first responders, to safely and effectively respond to, address and stop an active shooter.

The ALERT program is open to all state-certified peace officers, federal law enforcement officers and military personnel in good standing with their units.

The 40-hour instructor-level course begins with the two-day ALERT basic course and is followed by three days of intense teaching techniques, role-playing and in-depth explanation of the curriculum.

Benefit Cost Analysis Workshop

FEMA has completely reengineered the BCA program. This two-day workshop will cover each of the reengineered modules with specific emphasis on the flood module. Local planners, project officers or government officials who develop project applications for any of the hazard mitigation grant programs [Hazard Mitigation Grant Program (HMGP), Pre-Disaster Mitigation (PDM), and Flood Mitigation Assistance (FMA)] are encouraged to attend.

Many communities are in the process of completing project grant applications under the Hazard


Mitigation Grant Program (HMGP) from Disaster 1763. All mitigation project applications require a FEMA-approved BCA as part of the application. Project selection for funding is determined, to a large extent, based on the validity of the Benefit Cost Analysis. Attendees will receive instruction and conduct practical exercises on completing the BCA process for projects that are typical in the state of Iowa including property acquisition. The State anticipates opening the HMGP to other mitigation projects (in addition to property acquisition) later this fall.

There is no cost to attend but travel, food and lodging will be the responsibility of the participant and will not be covered by FEMA or the State of Iowa. The training will be held at the State's Emergency Operations Center.

\$15.7 million for Other Needs Assistance programs, which may be used for disaster-related needs not covered by insurance of other assistance programs.

\$244.5 million for Small Business Administration Loans (\$155.3 for homeowners, \$89.2 for businesses)

\$413.2 for Public Assistance, which reimburses state and local government agencies and certain nonprofit

organizations for eligible disaster-related expenses.

The deadline to apply for Individual Assistance was Oct. 31. For those who have already registered, information about disaster assistance is still available by calling FEMA’s helpline at 1-800-621-FEMA (3362) between the hours of 7 a.m. and 11 p.m. seven days a week. Ω
