**Apply Now for Community Disaster Grants** 

Applications for the \$22 million Community Disaster Grant are due April 1, 2009. Applications, which are available at **www. iowahomelandsecurity.org**, can be sent in electronically to **cdg@ iowa.gov** or by certified mail if postmarked by April 1.

The new allocations, which now more accurately reflect actual damages, are also available at the Iowa Homeland Security and Emergency Management Web site, as well as a listing of the eligible 85 counties and incorporated cities.

#### The grant is intended to help cities and counties pay for unmet disaster needs from the floods of 2008. There are six very broad eligible categories for these funds. $\Omega$



#### **CARVER Methodology**

The nation's critical infrastructures face a myriad of physical and technical threats. These threats, whether natural or man-made, accidental or intentional, each carry a certain level of risk that could compromise national security, public safety and the economy. CARVER training (Critical Accessibility Recognizability Vulnerability Effect Recoverability) will offer participants an opportunity to learn how to plan and conduct a vulnerability assessment. The U.S. Department of Defense uses CARVER as an offensive target analysis tool and it has become a very effective defensive tool for critical infrastructure protection.

HSEMD will host two CARVER training sessions. Targeted personnel include analysts, assessors, incident planners, executive managers, law enforcement, fire and emergency management/homeland security personnel. The first training will be held May 27-29 at the State Emergency Operations Center in Johnston. The second training will take place June 1-3 at the Cerro Gordo Emergency Operations Center in Mason City. Travel and lodging are the responsibility of the participant. ### ESF Distribution Begins Soon

Iowa HSEMD has all 15 Emergency Support Functions (ESFs) in house and is working to get them ready for statewide distribution.

The first two pieces of the plan to be disseminated will be the Basic Plan and ESF 10 (Hazardous Materials). These will be distributed to all counties statewide no later than April 30, 2009.

The only planning requirement for counties for 2009 is ESF 10. There is an annual requirement (EPCRA) to update Local Hazardous Materials plans. HSEMD will accept Annex P in 2009, but strongly recommends converting to ESF 10. This single ESF is due to HSEMD by Aug. 1, 2009.

After these two pieces of the new version of the plan are disseminated (Basic and ESF 10), the rest of the ESFs will be released at a minimum of two per month. This pace will probably be accelerated if county partners are comfortable receiving them more quickly.  $\Omega$ 



### FEMA Assistance Tops \$1 Billion for 2008 Disasters

As of March 24, Iowans affected by last spring's tornadoes and flooding had been approved for just over \$1 billion in disaster assistance through the Federal Emergency Management Agency (FEMA).

Government entities and nonprofit organizations had been approved for \$638.5 million through the FEMA Public Assistance Program. Eligible expenses under this program are in the areas of emergency response, debris removal, and repair or restoration of disaster-damaged public infrastructure. Certain non-profit organizations providing essential services may also be eligible for funding under this program.

More than \$137 million had been approved for households that registered for FEMA's Individual Assistance Program. Included in this program is \$121.2 million for Housing Assistance, which provides for rental assistance and grants to make an owneroccupied structure livable, and \$16.1 million for Other Needs Assistance, which provides grants for disaster-related funeral, dental, and medical expenses.

The Small Business Administration had approved \$262 million in loans for homeowners and businesses, with \$160 million going to homeowners, and \$102 million going to businesses.  $\Omega$  Iowa Homeland Security & Emergency Management Division

### **HSEMD Employees Attend Leadership Training**

The Naval Postgraduate School's Center for Homeland Defense and Security in partnership with the U.S. Department of Homeland Security's National Preparedness Directorate, FEMA provides the educational opportunity for our nation's homeland security leaders to develop the strategies, policies and organizational elements needed to defeat terrorism in the United States.

The Executive Leaders Program consists of four week-long sessions conducted over a nine-month period in Monterey, Calif., at the Naval Postgraduate School's Center for Homeland Defense and Security facilities. Participants consist of approximately thirty senior local, state, tribal, federal government, military and private sector officials with homeland security responsibilities. They are selected on the level of their positions and homeland security responsibility as well as the homeland security knowledge and experience they bring to the table. The NPS Center for Homeland Defense and Security covers the costs of travel and lodging for each session.

HSEMD's Homeland Security Coordinator **Tom Baumgartner** recently completed his coursework and graduated from the Homeland Security Executive Leaders Program in February 2009.
