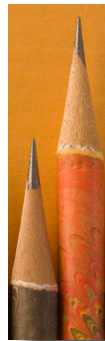
CIPP PLAN AVAILABLE

Grants Update for County Coordinators

Please keep in mind that just because grant management staff approve and forward reimbursements does not mean you will have your checks in the mail immediately. There are a number of steps and state agencies involved in processing your requests and at the very best it is a 30-45 day process. There will be

a flow chart available next week that outlines all of the steps and activity at each step.

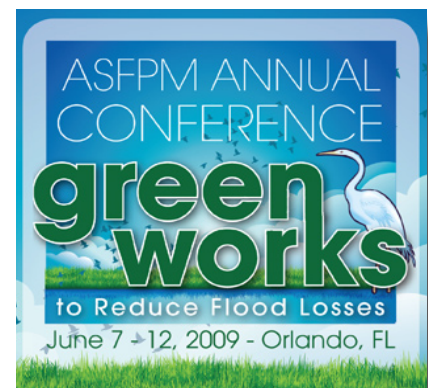

Next of Kin Registry Assists Local, State Emergency Agencies

The Next of Kin Registry (NOKR) was established as a free tool for daily emergencies and national disasters. This free proactive service stores emergency contacts, next of kin and vital medical information which could be useful to emergency response agencies and their family members.

NOKR's system has proven effective for missing, unconscious injured or deceased community members. Next of kin can be immediately contacted if seniors suffering from Alzheimer's are found carrying a registration card. The system has been utilized for national disasters including the 2009 flooding in Washington State, and the 2008 California wildfires, hurricane disasters, and flooding disasters in Iowa.

Stored information is accessible only by emergency services sector (ESS) agencies that have registered with NOKR at <http://nokr.org/nok/restricted/agencies.htm>, where system information and directions for the ESS can be found. The general public can click on <http://nokr.org> to obtain more information about NOKR or apply for its service. You may also access the NOKR site by going to the HSEMD Web site, www.iowahomelandsecurity.org, and clicking the "Public" tab at the top of the home page. On the right side of the Public page there is a link to the NOKR page.

NOKR has available an optional registration card that indicates the person is registered with them. Users can also obtain a free emergency contact decal to place on their driver's license or passport. Ω

'09 Homeland Security Grant Amounts Announced

The federal Department of Homeland Security has announced Iowa's awards for three homeland security grants. The amount for the State Homeland Security Grant rose to \$6.5 million, compared to the \$6.1 million received last year. While announced, the official award will actually come in 30 to 45 days. The state will then work with local and state partners to decide on the final obligations.

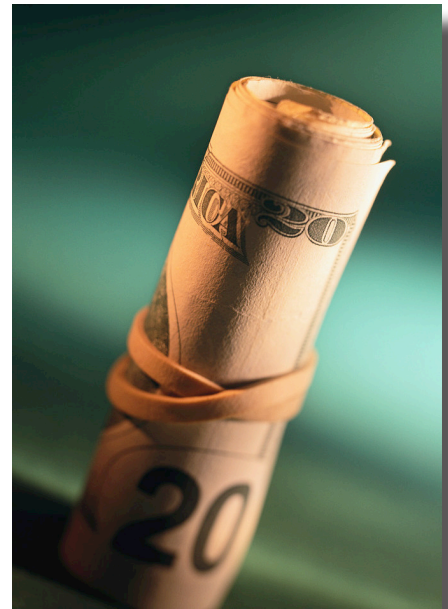
Earlier this year members of the First Responder Advisory Committee helped to review, rank and make preliminary recommendations on investment packages to be funded under this grant. Fourteen packages were submitted for a total of almost \$6.7 million.

The investment packages were:

- Incident Management Team, \$40,000
- WMD-SWAT, \$213,000
- Explosive Ordinance, \$541,500
- WMD HAZMAT, \$496,000
- University of Iowa Hygienic Lab, \$195,000

- Food and Ag security, \$190,000
- Local/State Official training, \$13,750
- Multi-State Partnership, \$218,213
- NIMS, NRF Implementation, \$1,160,000
- National Infrastructure Protection, \$526,750
- National Initiatives/ Regionalization, \$357,000
- Intelligence and Information Sharing, \$1,871,587
- Urban Search and Rescue, \$445,000
- Continuity of Operations and Government, \$400,000

These packages will now be reviewed and refined to meet the final grant amount. (For more details on these packages go to the Feb. 26, 2009, issue of **Secure and Prepared**, found in the newsletter archive section of the Iowa Homeland Security Web site.)



The other grant awards were:

- Metropolitan Medical Response, a direct pass through to the City of Des Moines, \$321,221 the exact same amount received last year.
- Citizen Corps, designed to build local citizen response teams and promote family preparedness, \$194,673 compared to \$195,388 last year. Ω

CSB is an independent federal agency charged with investigating industrial chemical accidents. The Board strives to be a leader in the

What does special needs mean? For emergency services, it means any individual, group or community whose circumstances make it difficult to comfortably or safely access and use the standard resources offered in disaster preparedness, relief and recovery.

Some examples:

- A person with a disability whose needs cannot be met in a shelter
- A non-English-speaker who does not understand the order to evacuate or other directions by emergency officials, or is reluctant to ask for help
