**Economic Planning and Redevelopment Corporation**

- Seeking significant disaster recovery grant from the U.S. Department of Commerce.
- U.S. Department of Commerce has provided money for public-sector ideas related to economic development in other cities hit by natural disasters. Possible uses include transit, power generation and the downtown steam system.

**Iowa State University Center for Industrial Research and Service (CIRAS) ([www.ciras.iastate.edu](http://www.ciras.iastate.edu))**

- CIRAS teams continues to explore opportunities and to offer solutions to assist manufacturers (total=18 companies) in exceeding pre-disaster production levels. Examples of assistance include facility layout, materials testing, Kaizen events, productivity improvement and education on conducting business with federal, state and local agencies along with identifying current and future procurement opportunities for Iowa businesses.
- CIRAS is exploring opportunities/needs for hosting workshops to address common industry recovery challenges and collecting lessons learned on preparation, disaster response, and recovery in industry.

**Rebuild Iowa Office ([www.rio.iowa.gov](http://www.rio.iowa.gov))**

- Rebuild Iowa Office released the "Iowa Recovery Times", an informative guide targeted at Iowans impacted. The newsletter can be viewed on line at [www.rio.iowa.gov/news](http://www.rio.iowa.gov/news).
- Lt. Governor Patty Judge, Assistant U.S. Secretary of Transportation Thomas Barrett and Vice Admiral of the U.S. Coast Guard announced that Iowa will receive more than \$23 million in federal support to help rebuild roads damaged by this year's severe weather.
  - 1500 miles of roads and 400 miles of rail were damaged
  - Funds will help reimburse state and local governments for temporary repairs made to roads, and make permanent repairs to the federal roads and bridges.
- Governor Chet Culver and Congressman Dave Loebsack announced that \$7.3 million in state and federal funds have been identified and is in the final stages of federal approval for Linn County.
  - Funds will be used to repair the Options of Linn County Building, a public service and rehabilitation building for the special needs population.
  - This is one of an expected 8,500 projects that will be identified under the State/FEMA Public Assistance program designed to help public and certain non-profit agencies.

- *SBA Application for Economic Injury Deadline – February 27, 2009*
- SBA Customer Service Representatives (CSR) staffing 1 fixed Disaster Recovery Centers (DRCs).
- Operating 1 Disaster Loan Outreach Centers (DLOCs) throughout the state.
  - SBA Customer Services Representatives are available at each location to meet with homeowners, renters, and non-farm businesses of all sizes to provide program information, help applicants complete paperwork and forms, and to close approved SBA disaster loans.
- Continues to sponsor a Business Recovery Center (BRC) at Westdale Mall in Cedar Rapids, where SBA has assisted over **3,300** visitors at the center.
  - Available to answer specific questions about how a disaster loan may help each business and to help owners' complete business loan applications.
  - Sponsors the availability of multiple additional services at the BRC and there is no charge for any of the services.
