# **Counties Added to Disaster Declaration**

Three Iowa counties have been added to a July Presidential Disaster Declaration.

Two counties – Appanoose and Wapello – have been added to the declaration for Individual Assistance, and another county – Pocahontas – is eligible for Public Assistance.

Individual Assistance can include grants for temporary housing and home repairs, low-cost loans to cover uninsured property losses, and other programs to help individuals and business owners recover from the effects of the disaster. Public Assis-

### tance funds are available to state and local governments and certain private nonprofit organizations (including rural electric cooperatives and municipal utilities) for emergency work and the repair or replacement of disaster-

damaged facilities.

The 34 counties now eligible for federal Individual Assistance are: Appanoose, Black Hawk, Cherokee, Clayton, Decatur, Delaware, Dubuque, Fayette, Franklin, Hamilton, Howard, Humboldt, Ida, Jackson, Jasper, Jones, Kossuth, Lee, Lucas, Lyon, Mahaska, Marion, O'Brien, Osceola, Polk, Ringgold, Sioux, Story, Taylor, *Continued on Page 2...* 

# More Counties Receive Secretary of Agriculture Disaster Designation

U.S. Secretary of Agriculture Tom Vilsack has designated 11 Iowa counties as primary natural disaster areas, making assistance available to agriculture producers in those counties, as well as 44 contiguous counties.

The 11 primary counties included in this latest Secretarial Disaster Designation have been designated due to losses caused by severe storms with excessive rain, flooding and flash flooding, hail, high winds and tornadoes that occurred from April 25 through Aug. 15, 2010. Those

counties are: Audubon, Delaware, Dubuque, Hamilton, Henry, Mahaska, Muscatine, Pottawattamie, Story, Warren and Wright.

Application Deadline Approaches The deadline to apply for Individual Assistance is Oct. 13, 2010.

Residents and business owners who sustained losses in the 34 designated counties may register for assistance online 24/7 at www.DisasterAssistance.gov or by calling 1-800-621-FEMA (3362) or 1-800-462-7585 (TTY) for the hearing and speech impaired. The toll-free telephone numbers are available from 7 a.m. to 10 p.m. daily, local time, until further notice. Applicants registering for aid should be prepared to provide basic information about themselves, details on insurance coverage, and any other information to help substantiate losses. Applicants may also visit one of several disaster recovery centers located throughout the state. The centers are staffed by representatives from FEMA and the Small Business Administration who are available to answer questions and provide recovery information. To

locate a disaster recovery center, go to www.fema.gov/assistance/ opendrcs.shtm.

Public Assistance Funding There are now 59 counties eligible for federal Public Assistance funding.

Applicants in 32 of the counties have until Sept. 27, 2010, to request Public Assistance: Adams, Appanoose, Audubon, Buena Vista, Butler, Cherokee, Clay, Davis, Decatur, Franklin, Howard, Humboldt, Iowa, Lee, Lyon, Madison, Marion, Mills, Monroe, Montgomery, O'Brien, Osceola, Palo Alto, Ringgold, Shelby, Union, Van Buren, Wapello, Warren, Wayne, Webster and Wright.

Applicants in 26 of the counties have until Oct. 9, 2010, to request Public Assistance: Black Hawk, Boone, Buchanan, Calhoun, Clarke, Clayton, Dallas, Delaware, Dickinson, Dubuque, Emmet, Fayette, Guthrie, Hamilton, Henry, Ida, Jackson, Jasper, Jones, Keokuk, Lucas, Mahaska, Polk, Sioux, Story and Washington.Ω

The 44 contiguous counties included in the new declaration are: Adair, Boone, Buchanan, Carroll, Cass, Cedar, Cerro Gordo, Clarke, Clayton, Crawford, Dallas, Des Moines, Fayette, Franklin, Guthrie, Hancock, Hardin, Harrison, Humboldt, Jackson, Jasper, Jefferson, Johnson, Jones, Keokuk, Kossuth, Lee, Linn, Louisa, Lucas, Madison, Marion, Marshall, Mills, Monroe, Montgomery, Polk, Poweshiek, Scott, Shelby, Van Buren, Wapello, Washington and Webster.

Additional counties may be added to the Secretarial Disaster Designation.

This Secretarial Disaster Designation makes farm operators eligible to be considered for certain types of assistance from the Farm Service Agency (FSA), including emergency loans and the Supplemental Revenue Assistance Payments (SURE) Program. Producers should contact their local FSA office for additional information.

On Aug. 24, Governor Culver received word that Secretary Vilsack had designated 20 counties in lowa as primary disaster areas and 32 counties as contiguous counties, as the result of severe storms, excessive rain, flooding, flash flooding, hail, high winds and tornadoes that occurred from April 25 to July 18, 2010.  $\Omega$
